## **Gosport Community Infrastructure Levy (CIL)**

CIL Financial Report 1<sup>st</sup> April 2018 – 31<sup>st</sup> March 2019



## Introduction

- 1.1 The Community Infrastructure Levy (CIL) is a charge on development which is set by the Borough Council to help fund important infrastructure needed to support new development in the Borough. The CIL charges in Gosport became effective from 1<sup>st</sup> February 2016.
- 1.2 Under Regulation 62 of the Community Infrastructure Levy Regulations 2010 (as amended) there is a requirement on CIL charging authorities to publish a report for any financial year which:
  - a. It collects CIL, or CIL is collected on its behalf; or
  - b. An amount of CIL collected by it or by another person on its behalf (whether in the reported year or any other) has not been spent.
- 1.3 To help provide further clarification about how CIL is collected in the Borough, the Council has produced a Guide to the Community Infrastructure Levy (December 2015). This is available on the Council's CIL webpage at: <a href="https://www.gosport.gov.uk/cil">www.gosport.gov.uk/cil</a>
- 1.4 This financial statement sets out information relating to income received and expenditure (including monies collected but not yet spent) based on the financial year starting on the 1<sup>st</sup> April and ending on 31<sup>st</sup> March. This Financial Statement covers the period 1<sup>st</sup> April 2018 31<sup>st</sup> March 2019. Since the CIL was introduced a total of £560,380.38 has been received.
