
As Chairman of the GCYPLP I am delighted to welcome you to the first Children and Young People's Plan for Gosport.

MISSION

This plan, through partnership working and the active participation of children and young people in Gosport, will raise the aspirations and expectations of children and young people and improve their health and well-being.

BACKGROUND

To meet the requirements of The Children Act 2004, the Government's green paper "Every Child Matters" and the United Nations Convention on the Rights of the Child, Gosport's Local Strategic Partnership invited key strategic leads and delivery managers responsible for delivering services to children and young people in Gosport, to form a Children and Young People's Locality Partnership to:

- Provide the strategic leadership in the planning, delivery and monitoring of services and support for children, young people, their families and carers in Gosport
- Be Gosport's multi-agency group responsible for ensuring the effective and efficient delivery of services to improve outcomes for children and young people.

At its first meeting in December 2006, the Gosport Children and Young People's Locality Partnership (GCYPLP) agreed its membership to ensure representation from key stakeholders (Appendix A) and established the Group's Terms of Reference (Appendix B). One of the primary tasks of this group has been to develop this Children and Young People's Plan for Gosport.

IMPROVING OUTCOMES FOR CHILDREN AND YOUNG PEOPLE

The Children Act 2004 placed a statutory requirement on all local authorities who are responsible for providing Children's Services to produce a Children and Young People's Plan (CYPP).

The purpose of this Plan is to improve outcomes for children and young people to help improve their quality of life enabling them to:

- Be Healthy
- Stay Safe
- Enjoy and Achieve
- Make a Positive Contribution
- Enjoy Economic Well-being.

To meet this duty, Hampshire County Council (HCC), who are the Children's Services Authority for Hampshire, worked in partnership with all sectors of the community to develop a county-wide CYPP. Following extensive consultation with all districts within Hampshire, the county-wide CYPP, which incorporated an action plan, was published in November 2006.

In order to deliver the actions within the county-wide plan, each district, through its locality partnership, has worked to produce a local plan to address local issues and needs based on the county-wide CYPP.

THE GOSPORT APPROACH

The GCYPLP considered the following information to gain a better understanding of the issues which affect children and young people in Gosport to ensure the appropriate key priorities are included within this Plan:

1) Profile of Gosport

a) Population

There are 11,711 young people between the ages of 0 – 11 years in the Borough with a further 8,128 aged 12 – 18 years. This represents 6% of the total population in Gosport.

Wards currently with the highest proportion of residents under 16 years of age in the Borough are: Grange (35.6%), Rowner and Holbrook (25.6%) and Forton (24.7%). The Borough average is 20.6%, close to the national average of 20.2%.

Wards with the highest proportion of residents aged between 16 and 24 years are Brockhurst (20.3%), Anglesey (14.6%) and Grange (13.7%). The borough average for this group is 11.5%.

b) Household Composition in Gosport

- 7,031 (22.5%) couples with dependent children (1)
- 2,099 (6.75%) lone parents with dependent children
- 533 (1.7%) other households with dependent children

c) Poverty and Deprivation

Gosport is ranked the 165th most deprived Local Authority area in England out of 354 and is the second most deprived district in Hampshire. Indices of deprivation include information at below ward level known as Super Output Areas (SOAs). Hampshire contains 28 SOAs, located across five districts that are classified within the 20% most deprived areas in England. Of these 28 SOAs, 4 are located in Gosport. These are within the wards of Town, Grange and Leesland.

PRIORITY OUTCOMES FOR GOSPORT'S CHILDREN AND YOUNG PEOPLE'S PLAN (GCYPP)

The priority outcomes which have been identified in this Plan (shown on pages 7 – 14) take into account Gosport's profile, data sets, consultation results, local information, local strategies and plans.

DELIVERING GOSPORT'S CHILDREN AND YOUNG PEOPLE'S PLAN

As there are no additional resources available to deliver this Plan, service providers will need to realign their own plans and resources to deliver improved outcomes for children and young people.

There is a need to work "smarter" together, using our existing partnerships and networks and building new ones. Innovative ways of making the maximum and best use of available resources will need to be developed to ensure that the lives children and young people in Gosport are improved.

ACTION PLAN FOR GOSPORT'S CHILDREN AND YOUNG PEOPLE'S PLAN

An accompanying action plan will be developed in consultation with key stakeholders to deliver the priorities within this Plan.

The GCYPLP will monitor and review this action plan to ensure that it reflects:

- Current and emerging legislation and guidance
- Current and emerging data and information
- Consultation findings
- The views and opinions of children, young people, their families and carers.
- Feedback from stakeholders

PRIORITY OUTCOME:

INCREASED HEALTHY EATING AND PHYSICAL ACTIVITY AND REDUCED OBESITY (Ref: HE)

Why is this important?

- Obesity decreases life expectancy by up to nine years and substantially increases the risk of many diseases, including heart disease, cancer and diabetes. It has been estimated that if childhood obesity continues to rise at the current rate, children could soon expect to die younger than their parents.

- Levels of obesity and overweight have increased steadily over the last decade. Obesity has doubled in six year olds (to 8.5%) and trebled among 15 year olds (to 15%)

- In the South East, 4.5% of boys and 4.9% of girls aged 2-15 years are obese and a further 15% of boys and 19% of girls are overweight.

- In the South East 33% of children and school entry age were overweight. In Gosport 14.5% of children at school entry age were found to be obese.

- Whilst there is good evidence that physical activity is essential for both good physical and mental health, increasing sedentary lifestyles and poor diet are resulting in inactivity, obesity and overweight in the population.

- In the South East, at ages 2–10 years, 14% of boys participate in sports activities on 5 days or more per week; double that of girls. For those aged 11–15 years, more boys are still participating in sports for 5 days or more than girls (16% compared to 12%).

PRIORITY OUTCOME:

IMPROVED SEX AND RELATIONSHIP EDUCATION AND
REDUCED TEENAGE PREGNANCIES (Ref: TP)***Why is this important?***

- The consequences of poor sexual health, including unwanted pregnancies or pregnancy among under 18s, or long-term ill health due to infections, can have a major impact on the lives of individuals, affecting their education, employment prospects and housing.

- Between 2000 and 2004, across the South East as a whole, the greatest increase in new sexually transmitted disease infections has been seen in the under 16 age group (almost 40%). The greatest increase in new episodes was seen in Hampshire and the Isle of Wight.

- In 2003 – 05, Gosport had the highest district rate in Hampshire with 45.0 conceptions (per 1000 young women aged 15-17 years), compared to the Hampshire rate of 30.6 and England rate of 41.6.

PRIORITY OUTCOME:

**IMPROVED SAFETY AWARENESS AND CHILD PROTECTION
(Ref: CP)**

Why is this important?

- Gosport has the smallest under age 18 population and the fourth highest referral rate in Hampshire below Havant, New Forest and Rushmoor. Gosport has the second highest number of child protection registrations in Hampshire, the highest being Basingstoke & Deane.

- Gosport has the fourth highest (30 in total) number of crimes against children in Hampshire - defined as: the incidence of identifiable crimes against children:

abandoning a child under the age of 2	- 15
abuse of trust – sexual	- 0
child abduction	- 5
cruelty or neglect	- 6
gross indecency	- 1
unlawful sexual intercourse	- 3

- When population is taken into account Gosport and Havant have the highest rates of children looked after (by parental residence).

PRIORITY OUTCOME:

REDUCED INCIDENCE OF BULLYING (Ref: IB)

Why is this important?

- Bullying breaks children down. It is shameful, humiliating and frightening, and young people often feel powerless to stop it. And it doesn't just affect children's social lives. Concentration lapses and skipped lessons are not uncommon for bullied children, even for those who have always performed well in school. Sometimes the thought of going to school is so terrifying that children pretend they are ill or refuse to attend. A very few find life so unbearable that they attempt suicide. Many more carry the effects of bullying long into their adult lives.

- The HCC Pupil Attitude Survey 2006 found that in Gosport, bullying in school or in the playground occurred for:
 - 34.1% of year 2 pupils
 - 24.3% of year 6 pupils
 - 28% of year 7 pupils
 - 18.9% of year 9 pupils.

and that in Gosport, bullying or “being picked on” outside of school occurred for:

- 31.7% of year 2 pupils
- 25.2% of year 6 pupils
- 21.5% of year 7 pupils
- 10% of year 9 pupils.

PRIORITY OUTCOME:

IMPROVED EDUCATIONAL ATTAINMENT (Ref: EA)

Why is this important?

- Skills are a key driver of fairness; unequal access to skills has contributed to relatively high rates of child poverty and income inequality in the UK. There are clear links between skills and wider social outcomes, such as health, crime and social cohesion.

- Absence represents an educational loss to young people themselves – absence from school can make a big difference to pupil achievement. Pupils with high absence rates are much more likely to leave school with fewer or no qualifications and they are more at risk of being drawn into undesirable activities, including crime and anti-social behaviour.

- Young people in Gosport are more likely to be absent from school than other young people in Hampshire and the rest of the country. Gosport has the highest number of half-day sessions missed by pupils due to authorised or unauthorised absences in Hampshire.

- In 2004 Gosport had the second highest pupil absences within the Local Education Authority at both primary school and secondary schools levels and above the national average for secondary school absences.

- Exclusions in Gosport from primary schools in 2004/05 were 0.02% (same as Hampshire) and secondary schools were 0.34% compared with Hampshire 0.27%.

- GCSE achievement in schools in Gosport is lower than the England average

- Gosport has the lowest percentage of pupils achieving 1 or more GCSE or equivalent passes at A*-G grade at the end of Key Stage 4 and the lowest progress between Key Stage 2 and Key Stage 4 in 2005 in Hampshire

PRIORITY OUTCOME:

INCREASED OPPORTUNITIES FOR PLAY, LEISURE AND RECREATION FOR ALL (Ref: PL)

Why is this important?

- A quality sport, recreation and play infrastructure plays a significant part in improving health, fostering community development and social integration. Life skills developed through play helps build self-confidence, personal motivation, independence and resilience amongst children and young people and helps reduce the risk of the development of mental health problems.

- There is an overall poverty of play opportunities in the general environment (GBC Play Strategy 2007-2012). There is a borough wide deficiency of provision for children and young people with significant shortfalls in areas where there are high proportions of under 16 year olds and under 10 year olds including Grange Ward.

- When residents were asked “generally thinking, what would you say are most important in making somewhere a good place to live?” out of 20 options:

Activities for teenagers was ranked 10th
Parks and Open Spaces was ranked 8th
Facilities for young children was ranked 16th.

When residents were asked “and thinking about your local area, which things, if any, do you think most need improving?” out of 20 options:

Parks and open spaces was ranked 15th
Activities for teenagers was ranked 3rd
Facilities for young children was ranked 13th.

- In the South East, for children aged 2–11 years, 4% of boys reported doing no active play compared to 6% of girls. In the older age groups the situation has worsened with 9% of boys reporting no active play and 27%, of girls. For those reporting 5 days or more active play, both boys and girls experience a decrease at the older age group. However, at ages 11–15 over half of boys (58%) are still reporting 5 days or more active play but for girls this has decreased to only 37%.

PRIORITY OUTCOME:

INCREASED VOCATIONAL AND WORK RELATED LEARNING OPPORTUNITIES FOR 14-19 AGE GROUP (Ref: VL)

Why is this important?

- Work related learning enriches the curriculum and learners' experience by providing a broad range of learning activities that have been shown to help raise standards, improve participation, increase attainment and support the delivery of improved outcomes for young people.

- In November 2006, 6.91% 16-19 years olds in Gosport were not in education, employment or training (NEET). The national target is 4.5%.

- Staying on rates for year 11 pupils in full-time education and training is 75% compared to the Hampshire average of 78%. Certain parts of the Borough have markedly lower 16-18 participation rates in further education and training than other parts of the South East. Those wards with a particularly low rate are: Rowner and Holbrook (below 60%), Hardway, Lee East (both with 62-74%), Forton, Peel Common and Bridgemary North (all with 64-66%).

PRIORITY OUTCOME:

REDUCED HOMELESSNESS AND IMPROVED HOUSING ARRANGEMENTS FOR THOSE IN UNSUITABLE ACCOMMODATION (Ref: HA)

Why is this important?

- 16 and 17 year olds housed in Bed and Breakfast are extremely vulnerable to exploitation from other residents. Feelings of isolation are further increased when young people are housed away from their friends or family and without enough money to travel to see them or to access services, support and education. They are isolated from the support they need and at risk of dropping out of mainstream society altogether.

The poor living conditions in Bed and Breakfast can adversely affect those who are housed there. Most 16 and 17 year olds are not mature enough, or do not have the necessary life skills to live on their own in insecure accommodation for long periods of time.

Drug misuse is closely linked to social exclusion and young homeless people are particularly at risk of developing patterns of problematic substance misuse. There is a strong relationship between an increase in drug use and a worsening accommodation situation as young drug users often face high levels of exclusion from housing opportunities and services set up to assist them.

- The Gosport homelessness profile is currently 3 to 4 times the rate of other Hampshire districts. In Gosport 15% is the average for under 18 year olds, 8.5% is the national average whereas the average for Basingstoke and Portsmouth is less than 5% (both having specialist young persons accommodation in the district, Foyers).

- Currently, 79% of young people accommodated in emergency accommodation in Gosport are evicted for arrears or behaviour. This can result in any future application for permanent housing being severely downgraded and can seriously effect chances of getting a home in the future.

TERMS OF REFERENCE

Gosport Children and Young People's Locality Partnership (GCYPLP)

1.0 Aims and Objectives

- 1.1 To provide strategic leadership in the planning, delivery and monitoring of services and support for children, young people, their families and carers in Gosport.
- 1.2 To be Gosport's multi-agency group responsible for ensuring the effective and efficient delivery of services to improve the outcomes for children and young people as detailed in "Every Child Matters":
 - Be Healthy
 - Stay Safe
 - Enjoy and Achieve
 - Make a Positive Contribution
 - Economic Well-being
- 1.3 To improve, promote and facilitate partnership co-operation and joint working between agencies.
- 1.4 To develop a culture that promotes inclusion and equity enabling children, young people and their families and carers to be partners in the development of services.

2.0 Role

- 2.1 To support the delivery of the Change for Children Programme, the Local Area Agreement (LAA) and the National Services Framework (NSF).
- 2.2 To work together to deliver integrated services, shared information and shared resources to improve outcomes and reduce inequalities for children, young people, their families and carers
- 2.3 To develop, deliver, monitor and evaluate a Children and Young People's Plan for Gosport (GCYPP), agreeing key local priorities and targets to enable joint planning and commissioning of services to achieve better outcomes
- 2.4 Deliver opportunities to ensure the full, active and equitable participation of all stakeholders including children, young people, their parents and carers in the planning and monitoring effectiveness of services.
- 2.5 To consult and communicate with the wider stakeholder group in order to shape local priorities and deliver services ensuring that the views and needs of children, young people, their families and carers are taken into account.

- 2.6 To provide information and support the Hampshire Children and Young People's Partnership Standing Conference and Management Board ensuring a local perspective.
- 2.7 To ensure the necessary links are made and maintained between local partnerships with specific functions e.g. the Community Safety Partnership, Gosport Partnership Board, NHS Implementation Groups and Community Strategy Groups.
- 2.8 Promote and enable effective communication between agencies, partner organisations and service providers.

3.0 Partnership Structure

- 3.1 The GCYPLP is a sub-group of the Gosport Partnership Board (GPB) and is linked to the HCC Children and Young People's Partnership Management Board.
- 3.2 The GCYPLP will be supported by various groups and outcome partnerships which will lead on delivering specific actions detailed in the Gosport Children and Young People's Plan.

4.0 Membership

- 4.1 The GCYPLP will operate via a core of key members whilst sustaining and communicating with a wider stakeholder group. Wherever possible, the Chair of the GCYPLP will be a current member of the GPB.
- 4.2 Members will include strategic leads and key delivery managers from relevant agencies who are of sufficient seniority to be able to commit resources and deliver actions on behalf of their organisations.
- 4.3 The key member organisations of the GCYPLP will include:

5.0 Accountability

- 5.1 Members of the GCYPLP as a sub-group of the GPB will maintain links to the GPB. The GCYPLP will also maintain links to the HCC Children and Young People's Partnership Management Board; local and county elected member for and Hampshire Action Team (HAT).
- 5.2 The Chair, as a member of the GPB will report to the GPB and communicate information from the GPB to the GCYPLP.
- 5.3 Each organisation will retain governance of their responsibilities and partners will identify the most appropriate involvement consistent with their role as detailed above.
- 5.4 Members will develop corporate responsibility to ensure joint working in challenging and supporting partners in improving outcomes.
- 5.5 The GCYPLP will review its structure, membership and activities annually and present its findings to the GPB.

6.0 Meetings

- 6.1 A Chair and vice-chair will be elected annually.
- 6.2 The GCYPLP will meet at least four times per year at regular intervals.
- 6.3 Members of the GCYPLP who are unable to attend a meeting will be required to send a representative to attend on their behalf.
- 6.4 Members of the GCYPLP may, with the prior agreement of the Chair, invite others to attend meetings to provide information and/or guidance on specific issues.
- 6.5 Additional meetings may be arranged as necessary with the prior agreement of the Chair and attached officer.
- 6.6 The Chair will determine the agenda for all meetings.
- 6.7 Meetings will be minuted and copies will be forwarded to:
 - Members of the GCYPLP
 - GPB co-ordinator for publication on the GPB website and circulation to GPB groups
 - HCC CYP Partnership Management Board.

7.0 Equality

- 7.1 The GCYPLP is committed to fair and equal treatment for all, in accordance with the law and recognises the value of diversity.
