**Positively prepared** - the plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development;

**Justified -** the plan should be the most appropriate strategy, when considered against the reasonable alternatives, based on proportionate evidence;

**Effective -** the plan should be deliverable over its period and based on effective joint working on cross boundary strategic priorities; and

**Consistent with National policy -** the plan should enable the delivery of sustainable development in accordance with the policies in the Framework.
