**Positively prepared** - the plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development;

**Justified -** the plan should be the most appropriate strategy, when considered against the reasonable alternatives, based on proportionate evidence;

**Effective -** the plan should be deliverable over its period and based on effective joint working on cross boundary strategic priorities; and

	The Strategy's coverage of economic development is not sound, because it fails to deal with the prime sites for development and entrepreneurial operations that are being ignored due to land given over to car parking		
5.	Please set out what change(s) you consider necessary to make the Local Plan legally compliant or sound, with reference to the answer you have identified in Q3. You will need to say why this change will make the Local Plan sound.		
	A large area of the Waterfront, Town Centre and Haslar Lake areas are taken up with open air parking, both creating an eyesore, and limiting development of the area. Alternative ways to provide the required levels of parking should be found which allow for these sites to be developed sympathetically, and improve the quality of the realm. In particular there are four areas which could be redeveloped to include underground parking so greatly increasing the opportunity for retail and residential capacity.		
	a. Mumby Road bus station car park in Waterfront area		
- 1	This space can be replaced with underground parking beneath any waterfront development built on the site of the bus depot The current 20 spaces could be increased to up to 100 if a multi level underground car park is implemented.		
	b. South Street car parks in Gosport Town Centre area		
	This area is ripe for a 'Lanes' style development of small live work units to add vitality and viability to the area. Any new development of these units would include underground parking to maintain access for visiting shoppers and visitors, and replace the current 'empty space' car park.		
	c. Haslar Marina car park on Haslar Road		
	This area is an active eyesore that counters the natural beauty of Haslar lake, and the two sympathetic developments in the immediate vicinity. A low impact extension of the existing Haslar Marina development in this space would vastly improve the realm, and add space for businesses and holiday lets.		
	d. South Street car park next to the boating lake		
	This area appears on the map to be included as a conservation area (rather than the lakes), whereas a suggested innovative use of space might be to restore a section of the earthwork wall through this car park, and provide parking underneath it.
