| Para 7.155 and Policy LP42 | The site is adjacent to internationally important <i>habitats</i> and consequently the relevant considerations (as set out in Policy LP42) apply. | This is a general comment relating to the title of Policy LP42. We consider this would be best titled 'Internationally Important Sites' or 'Internationally Important Species and Habitats' since it is not just the habitats that are of international importance, but also the numbers and diversity of wintering waterfowl that use the habitats. |
| Policy LP44 and associated paragraphs | Minor wording amendments relating to LP44 point 2, and paragraphs 12.85 and 12.86, and any others that may be relevant. | Whilst we welcome the use of this wording in this policy, we consider that the Borough Council should be aiming for a 'no net loss in biodiversity' and ensuring the ecological networks are maintained as well as prioritising BAP species. This approach is highlighted in paragraphs 109 (point 3) and 114 (point 1) of the NPPF and is a key theme in the Natural Environment White Paper. |
| Appendix F GO0015 Priddy's Hard | Amendments to SINCs | The Wildlife Trust has been objecting to the recent development proposals at Priddy's Hard (15/00165/FUL) and note the removal of the buildings from the SINC designation. We note that recent documentation submitted in support of the application states that an access road has also been removed from the SINC designation, this conflicts with what is stated in these revisions and on the revised map. Clarification is therefore requested. |
