HOW TO PAY YOUR **HOUSING CHARGES**

Did you know that rent is due in advance either weekly or monthly?

Your rent, charges or arrears can be paid in the following ways?

- Direct Debit pay monthly via your own bank or building society on either 1st, 8th, 15th or 22nd of each month. This can be set up over the telephone by contacting 023 9254 5665, when setting up your direct debit, please ensure that the bank account holder is present. Direct Debit mandates are available by calling 023 9254 5665.
- Telephone by calling 023 9254 5665 you can pay using your debit or credit card, between 9am and 5pm. If you want to make multiple payments for rent, council tax and any other payments please call 023 9258 4242.
- Standing Order you can set up a standing order either weekly, fortnightly, four weekly or monthly through your bank. GBC Bank sort code is 57-81-43 and account number is 00000000 -Borough of Gosport. Please guote your rent reference number when setting up this payment.
- Online Payment you can set this up online or with your bank using the account details, GBC bank sort code is 57-81-43 and account number is 00000000 - Borough of Gosport. Please quote your rent reference number when setting up this payment.
- In person pay at the Town Hall cashiers desk either by cash, cheque, debit or credit card between 9am and 4.45pm.
- Internet please look at www.gosport.gov.uk/online-payments
- All Pay card pay at the Town Hall cashiers desk or your local pay point/shop/post officer. Please call 023 9254 5665 to request an All Pay card.
- Outside office hours via the post or through the secure letterbox at the front of the Town Hall (it is not advisable to send cash as GBC cannot accept any responsibility for any lost payments). Cheques and postal orders should be made payable to Gosport Borough Council. Please ensure that you write your account number, name and address on the back of the cheque/postal order and make sure that the envelope is securely sealed.

FIREWORKS SAFETY

To many of us. 5th November means bonfire night and fireworks.

Celebrating bonfire night at home with fireworks can be fun, as long as they are used safely. Figures show that more children than adults are hurt by fireworks. In the past few years over 350 pre-school children were treated in hospital for injuries caused by fireworks.

Attending and organised bonfire and firework display is usually the safest way to enjoy bonfire night. If you are planning on organising your own event don't forget to remember the firework safety code:

- Fireworks must not be sold to any person under the age of 18 years.
- Make sure you buy fireworks marked BS 7114 or CE.
- Don't drink alcohol if setting off fireworks.
- Keep fireworks in a closed metal box.
- Follow the instructions on each firework.
- Light them at arm's length using a taper.
- Stand well back.
- Never go near a firework that has been lit, even if it doesn't go off, it could still explode.
- Never put fireworks in your pocket or throw them.
- Always supervise children around fireworks.
- Light sparklers one at a time and wear gloves.
- Keep a bucket of water nearby if you are setting fireworks in your garden.
- Never give sparklers to a child under five.
- Keep pets indoors.



If you are planning a bonfire

We would always recommend attending an organised bonfire or fireworks display, However if you are planning to host your own bonfire please follow these simple steps:

- Bonfires should be built at least 18 metres from things such as buildings, trees and fences.
- Do not use petrol or any other flammable liquid to start a bonfire.
- Always check inside the bonfire for animals and children who could be using them as a den.
- Think about fire safety and also the pollution bonfires can create.
- Don't site your bonfire too near your firework storage area.
- Never put fireworks on a bonfire.
- Never leave a bonfire unattended or leave it to smoulder - put it out.
- Once the bonfire has died down, spray the embers with water to stop it reigniting.

LOCAL AREA **ENFORCEMENT OFFICERS**

Your local area now has its own dedicated neighbourhood enforcement officer, on the lookout for problems such as littering, dog fouling, fly tipping and anti-social behaviour.

Following the expansion of our Streetscene enforcement team, from five to eight officers, the borough has been divided up, which means each area, has a dedicated officer.

The map and key show who your officer is.


Our aim is for officers to be visible to residents and have real responsibility for their patch. We believe that being close to the local community will help them tackle problems and make their areas better places to live and work in.

You may see officers walking, cycling or driving around the neighbourhood. They'll be mainly in uniform, but may use plain clothes if necessary, to help them detect offences.

Their duties will include inspecting council-run facilities such as parks and issuing penalty notices for offences such as dropping litter or dog fouling. They'll investigate fly tipping cases and help make sure businesses and residents are dealing with their rubbish properly.

They will also issue penalty notices for parking offences in council car parks (not on the road, which remains a police responsibility).

It's planned that the officers will work alongside police colleagues on reports of anti-social behaviour and cases of criminal damage in and around the council's parks and pavilions.



Tips for waste removal

Fly-tipping is the illegal dumping of waste.

It's a crime that damages the environment, risks public health and costs taxpayers to clean up.

Householder **responsibilities**

You could face an unlimited fine if your rubbish is found fly-tipped – even if you didn't do it yourself.

You must use a licensed waste carrier to dispose of waste, or take it to a household waste recycling centre (hants.gov.uk/ recyclingcentres).

> You must show you took reasonable steps to prevent your waste being fly-tipped. This is called your duty of care.

Using a licensed waste carrier 1. Check if your waste carrier

- is licensed. You can do this quickly with their name or licence number at hants.gov.uk/fly-tipping.
- 2. Ask what will happen to your waste. A licensed waste carrier should not object to this.
- **3.** Keep a record of their waste carrier licence number by taking a photo of the licence, or take a screenshot when you check online.
- 4. Keep a waste transfer note or receipt to say where the waste was collected from, by who, and where it is going.

CREATING A GREAT PLACE TO LIVE AT DAEDALUS VILLAGE



Daedalus originally served as a seaplane base in 1917 during the First World War and later became the main training establishment and administrative centre of the Fleet Air Arm. During the Second World War a number of Naval Air Squadrons were posted to the base however, following its decommissioning in 1996, the site fell into disrepair and was subsequently acquired by Homes England.

Work on the Deadalus Village development started in November 2018 after Homes England – the Government's housing delivery agency – chose Wates Residential to act as its trusted delivery partner. The site is one of seven national pilots designed to enable the Government to fast-track the building of homes on publicly owned land and diversify housing delivery.

The project will dramatically increase the number of new homes available in Gosport, with 120 private homes and 80 affordable homes being built at double the pace of the industry standard. The affordable homes will be managed by housing association, Radian.

SITE PROGRESS

Wates Residential fully completed the first roof on site in April – just five months after work started. The significant milestone was celebrated with a 'topping out' ceremony to lay the last roof tile of the new property.

The event was attended by local veterans that previously served at the base, Wates Residential staff, and local ward councillors, Cllr. Graham Burgess and Cllr. John Beavis MBE. A charity raffle was also held in aid of Gosport Voluntary Action.

CREATING VALUE

Wates Residential is driven by a shared vision that everyone deserves a great place to live. The national developer aims to leave a positive lasting legacy in the communities where it operates by targeting local procurement, the creation of local training and employment opportunities, and investing in local charitable organisations and community groups. As part of the Daedalus site, Wates Residential has:

- Donated over £68,000 to support local causes
- Spent over £12.9m with businesses in and around Gosport to help boost the economy
- Recruited a workforce made up of 35% local people
- Recruited 60 people into full time positions on site
- Invested 2,634 hours in supporting people through training and employment initiatives
- Invested the equivalent of £207,000 into training local people

BUILDING FUTURES

Wates Residential's Building Futures programme aims to assist NEETS (those not in education, employment or training) aged 19+ to gain valuable practical experience and employability coaching to reinvigorate their career prospects. The programme incorporates personal development skills training, such as confidence-building and behavioural skills, as well as CV preparation, interview skills and taster sessions in various trades. The programme also provides participants with the skills they need to complete the industry standard Provisional Construction Skill Certification Scheme (CSCS) test.

Two courses have been successfully delivered in Gosport. In June 2019 14 students graduated from the course after learning carpentry, maintenance, planning and health and safety at the Silver Trowel Centre in Leeon-the-Solent. The students also took part in mock interviews with local employment agencies and eight were offered jobs.

Gosport Borough Council tenant Grant, who attended the Building Futures course June 2018 said –

"The building futures course changed my world and has helped me kick start my career. Prior to bar work, under a zero-hour contract, I was unemployed and claiming an employment support allowance. I also suffered low level mental health issues. Now I am back in the world of work, earning money and being able to live again. Thank you to everyone who supported me to get to here, if it hadn't been for this opportunity I would probably be homeless."

DEVELOPING LOCAL SKILLS

In July Project Surveyor, James Burnett and Project Manager, Pete Mitham from Wates Residential presented two laptops to local charity, Loud and Proud. The charity facilitates volunteering for young people aged between 16 and 25 to help them learn new skills, feel part of the community and increase self-confidence. Members of the group are currently working towards the UK Youth Futureproof Awards and the laptops will enable them to access online resources to complete their portfolios.

Separately, Wates also provided Loud and Proud with two computers to help local residents improve their IT skills, support job seeking, save money and tackle social isolation by providing a platform for people to connect with each other.



Wates Residential has also been working closely with Gosport Voluntary Action (GVA) to fund worthwhile volunteering opportunities in and around Gosport. To date this has included helping to serve a Christmas dinner for local sheltered housing residents and successfully applying to Wates Giving for a grant of £4,828 to support GVA's Supported Volunteering Project. The project provides additional support for isolated individuals to become more active and engaged members of the local community through social action volunteering team.

The developer also successfully applied to Wates Giving for a grant of £13,500 in support of Age Concern Gosport – a small, independent community-based charity offering a friendly information service staffed by local volunteers to aid older people (55+).



CELEBRATING THE PAST, PRESENT AND FUTURE

In February, pupils from Lee-on-the-Solent Junior School and members of the Gosport Aviation Society and Lee Residents' Association (LRA) put forward more than 50 entries after a competition to name some of the roads and buildings on the site was launched by Wates Residential.

Chloe, a pupil at the school, said:

"The assembly this morning was great, I didn't know that Dunkirk was filmed here. Over the half term, I will be researching the old buildings and the people who were famous for flying the planes at Daedalus. I am hoping that one of my names will be selected, so that I can be part of history."

The competition was kick-started with an assembly at the school, with around 340 pupils, aged between 8 and 11 years, learning about the site's history as a Royal Naval Air Station. Amongst the names shortlisted was Courtship Lane, which was submitted by Year 6 pupil, Olivia. Her grandparents, James and Patricia, met and 'courted' whilst serving on the base. James was deployed to fight in the War, but survived a sniper attack to return to the local area and marry Patricia. The winning names, which were chosen by Gosport Council, include:


- Hurricane Court submitted by Katie, Year 4
- Lysander Court submitted by Matthew, Year 3
- Barracuda Court submitted by Austin, Year 4
- Seahawk Court submitted by Edward, Year 6
- Seafox Court submitted Macauley, Year 5





The winning names pay homage to the airplanes once stationed at the Daedalus base. Fairey Barracuda was a nimble dive bomber used to attack enemy battleships, it was first used by the Royal Air Force in 1943 and models were stationed in Gosport from 1944 to 1945. The Hurricane was a celebrated British single-seat fighter aircraft that took part in all major World War Two battles.

The competition came after pupils helped mark the start of work on the Daedalus Village site in November by burying a time capsule to celebrate the past, present and future of the site. More than 35 people including Gosport Borough Council leader Cllr Mark Hook, Gosport MP Caroline Dinenage and members of the LRA joined the students and Wates Residential to celebrate the significant step forward for the project.









BIRD BOXES AT BERYTON ROAD

Gosport Borough Council and our partners Novus Property Solutions are undertaking a major improvement project in the Beryton Road area. Part of this work includes installing new edge plastics including guttering and fascia's to help protect properties from weather damage and to improve the appearance of the properties.

A sharp eyed tenant noticed that one of the properties seemed to have swifts flying around it, possibly nesting within the roof eves, so he contacted the council who asked Novus to remove the soffits to the underside of the roof edge to ensure that the swifts could continue to access the roof area to nest. The response from Novus was fantastic and they removed the soffits the same day. An inspection was carried out to the surrounding areas and a few other properties also had swifts flying around. After consulting with the Swift-Conservation Organisation (www.swift-conservation.org) it became apparent that swifts are struggling to find nest sites and there has been a 50% reduction of swifts that migrate to the UK in the last 20 years. As a result, a decision was made to not fit the soffits in this area to allow swifts to continue to flourish in Gosport. The good news doesn't end there, Novus have decided that they want to help even more; they are going to build RSPB approved swift nesting boxes and fit them to a number of properties in Beryton Road who wish to have them; free of charge to give more nesting sites for these amazing birds. CASH TO HELP COMMUNITY PROJECTS



Did you know that groups and individuals can apply to the Gosport Community Fund which gives grants of £50 to £1,500,

from the proceeds of Gosport Community Lottery? So far the grant has handed out \pounds 6,360 after its first six months.

Now there is another pot of money, the Community Infrastructure Levy (CIL) Neighbourhood Fund, which will be giving grants of $\pounds1,500$ to $\pounds50,000$.

This grant comes from the Community Infrastructure Levy (CIL) which is a contribution that developers must pay when they build shopping centres or housing. It's aimed at improvements to community, sports and leisure facilities for cycling, walking and people with disabilities.

PROTECT YOUR HOME

We insure the building where you live but it is up to you to make sure that you insure the contents of your home and your personal possessions. Many of us are starting to think about buying Christmas gifts and by taking out contents insurance will ensure that these items will also be covered.

HOME CONTENTS INSURANCE SCHEME

There are many insurance companies available out there which can be found via internet search engines, alternatively you can obtain insurance through high street insurance brokers or banks.

Many insurance companies offer home contents insurance with a number of different payment options available.

We don't specify who you should take out your home contents insurance with, but we do have an agreement with Crystal Insurance. Details of their home contents insurance scheme can be found below.

CRYSTAL INSURANCE SCHEME ARE YOU PROTECTED?

Everyone at some time or another may suffer a disaster such as fire, flooding, burst pipes, theft or vandalism, which could damage the contents of your home. While it is sensible to take precautions to prevent catastrophes from happening, they are sometimes unavoidable. It can be very expensive if you have to replace furniture, clothing, carpets and electrical equipment. All tenants and leaseholders are responsible for insuring their contents against damages like these. Gosport Borough Council strongly advises all tenants and leaseholders to take out home insurance in some form.

You can do this by making your own private arrangements, or you can join the Crystal Insurance Scheme. This scheme is arranged in conjunction with Thistle Tenants Risks and can help our tenants and residents obtain home contents insurance easily and at a price that is affordable.

The scheme also allows tenants and leaseholders to extend their policy.

WHAT IS COVERED BY THE SCHEME?

Most of your household goods and contents including push bikes and computer equipment are insured when in your home. They are covered against loss or damage caused by specific events such as theft, fire and flood.

Tenants and leaseholders have the option to increase their cover to include Extended Accidental Damage, Personal Effects, Wheelchairs, Hearing Aids and the structure of Garages, Sheds and Greenhouses depending on their individual needs. Full details are available on request.

HOW DO YOU PAY?

You can pay your premiums by one of the following methods:

- Fortnightly or monthly by using a Swipe Card at any Post Office or Pay Zone outlet.
- Monthly by Direct Debit
- Annually by credit/debit card, cheque or postal order made payable to Crystal Insurance Scheme

WHO CAN APPLY?

The scheme is arranged with Allianz Insurance Plc and all Gosport Borough Council tenants and leaseholders are eligible to apply.

British Red Cross

GET SUPPORT AT HOME

You can get support and care from the British Red Cross to help you live independently at home or when you return after a stay in hospital.

If you are returning from hospital, the British Red Cross will make sure you have everything you need for your first 24 to 72 hours back at home. They may then provide up to 12 weeks of support depending on the level of help you need.

WHAT HELP YOU WILL GET?

They will assess your needs and help you decide what goals you want to achieve with their help. They can offer practical and emotional support including:

- Transport home from hospital
- Door-to-door transport for essential health-care journeys
- Help with everyday tasks (for example, picking up prescriptions and shopping)
- Companionship
- Rebuilding confidence
- Help arranging for bills to be paid
- Short term use of a wheelchair and toilet aids

HOW MUCH DOES IT COST?

The service is free of charge.

HOW TO GET HELP

You can be referred by someone else (such as a hospital, primary care trust or your GP) or you can contact your local service yourself.

HOW TO MAKE CONTACT?

You can contact the service, either by calling **07860 412799** or **023 9289 4210**, between 10am and 6pm.



TAKE FIVE

Take Five to Stop Fraud is a national campaign from Financial Fraud Action UK and the UK Government, backed by the banking industry. It's about taking that moment to pause and think before you respond to any text, email or phone call asking you to share any personal or financial details.

If you suspect someone is after your money, take five and confidently challenge them with this simple phrase:

"My money? My Info? I don't think so!"

Follow these tips to help you protect yourself from financial fraud.

REQUESTS TO MOVE MONEY

A genuine bank or organisation will never contact you out of the blue to ask for your PIN, full password or to move money to another account. Only give out your personal or financial details to use a service that you have given your consent to, that you trust and are expecting to be contacted by.

CLICKING ON LINKS/FILES

Don't be tricked into giving a fraudster access to your personal or financial details. Never automatically click on a link in an unexpected email or text.

PERSONAL INFORMATION

Always question uninvited approaches in case it's a scam. Instead, contact the company directly using a known email or phone number.

BE LOAN SMART

'Loan Smart' is a new charity, dedicated to helping people avoid borrowing from loan sharks and dodgy lenders.

If you suspect a loan shark, please report them to the Illegal Money Lending Team. You can report them via the Stop Loan Sharks website by using the 'Report them' link on **www.loansmart.org.uk**

Loan shark is a common term used to describe illegal lenders. Anyone charging interest on money loaned without proper authorisation from the Financial Conduct Authority (FCA) may be acting illegally. Illegal lenders cannot be trusted and borrowing from them may mean trouble for you. They are often friendly at first, but that is unlikely to last and can often lead to threatening or violent behaviour.

You can spot a loan shark by:

- No documentation Illegal lenders tend not to bother with paperwork or formal agreements – if your lender has not provided you with any documentation, they may be acting illegally.
- No checks on your ability to repay An authorised lender should usually make a reasonable assessment of your credit history to make sure that you can afford to make the repayments on your loan. If no checks are made, they could be a shark.
- They don't tell you how much you owe Loan sharks want to keep you in the dark about how much you owe. Are you clear about how much you have left to repay?

Catch a shark

In almost all cases, only firms and individuals that are authorised by the FCA are allowed to lend money in the UK, whether that is faceto-face or over the internet. The FCA makes sure that the authorised firms are lending responsibly, ensuring that consumers are protected.

Just because a lender appears to be above board, they may not be.

If you think that you are in danger right now or are being threatened by a loan shark, consider going to the police – even if a loan shark has threatened you with the police. Did you know that authorised lenders do not use the police to collect a debt! So remember, you are not in trouble and have done nothing wrong; they are the ones committing the crime and the loan is legally unenforceable.

Alternatively, if you are struggling to escape the clutches of a loan shark, get help by contacting the Illegal Money Lending Team either by calling **0300 555 2222**, texting **07860 022 166** or emailing **reportaloanshark@ stoploandsharks.gov.uk**. They will be able to help and support you and will also be able to investigate your situation more fully.

You can search on www.loansmart.org.uk to find out if a lender is registered with the FCA. If you think that someone could be a loan shark, here is what you can do next:

- Do nothing this is always an option but isn't going to help weed out illegal lenders. By sharing your experience, you might be able to help stop illegal lenders from preying on the vulnerable.
- Contact the Illegal Money Lending Team and tell them what is happening – they are hugely experienced and can really help.
- Get other help being loan smart is about getting support when you need it. There are lots of places you can get free, confidential advice, whatever you are worried about. The sooner you get help, the sooner you can start to put things right. Please see below some details of some organisations that may be able to help.

ARMED FORCES COVENANT



Gosport Borough Council recognises the contribution and sacrifice made by members of the armed forces community and the unique skills and attributes they bring to our workplace. We are proud to have signed the Armed Forces Covenant.

The Armed Forces Covenant is a voluntary statement of mutual support between a civilian community and its' local Armed Forces Community, which outlines the moral obligation between the Nation, the Government and the Armed Forces, at the local level.

Hampshire County and the District Councils were among the first counties to sign up to the Community Covenant. Gosport, Isle of Wight, Portsmouth and Southampton councils have come together to adopt a partnership approach to delivering the Covenant within the Solent region of the wider county of Hampshire. The aim of this partnership is to:

- Raise awareness among serving personnel, reservists and veterans of the support they can receive from local authorities.
- Provide a broader understanding of the needs of the local veteran population as well as serving personnel during transition to civilian life.
- Evaluate the impact of these initiatives.



THE ARMED FORCES **COMMUNITY IN GOSPORT**

Below are some interesting facts about the Armed Forces Community in Gosport.

- Gosport has five military sites where approximately 1,750 serving personnel are based.
- Gosport is home to five cadet units.
- 1,384 members of the Royal Navy have registered a home address in Gosport.
- There are a further 807 service accommodations across eight sites in Gosport with a capacity to hold a total of 2,324 people.
- 4,275 veterans have registered Gosport as their home address for the purposes of forces pension and or compensation payments.
- As of January 2019, there were 1,172 service pupils in Gosport, approximately 10.8% of the total school aged population in the Borough.

The Solent Armed Forces Covenant Partnership has recently opened a veteran drop-in service in Gosport, open to former members of the British Armed Forces and Reserves and their immediate family members, including the Royal Fleet Auxiliary and the Merchant Navy. The service is open on the last Friday of every month, from 10am to 2pm at the Gosport Discovery Centre.

This service provides social support and access to a wide range of welfare and mental health services. ENERGY SAVING TIPS TO KEEP YOU WARM THIS AUTUMN



The weather is starting to turn cooler and the days are getting shorter – autumn is here, and you can expect to see a rise in your energy bills as you try to keep warm and healthy in your home. Here are some tips that can help you reduce your energy use, and your bills.

- Turn your thermostat down by 1 degree. This can reduce your heating bill by up to 10%, and you're not likely to even notice the difference! Remember to keep your home within the healthy temperatures of 18-21 degrees.
- Turn lights off that aren't important. This is especially important if you are using older, less energy efficient lightbulbs. Have you considered getting low energy use LED bulbs fitted?
- Avoid using standby on electrical devices. Devices on standby use almost as much energy as when they are being used. You can get standby saver plugs which turn devices off from your remote.

- Wash clothes at 30 degrees. Reducing the temperature if you wash from 40-30 degrees could cost you 40% less!
- Switch to a cheaper energy tariff. Thanks to the Energy Switch Guarantee, it's easy to switch to a cheaper tariff to save on your bills. On average, people save up to £270 off their bills by switching.
- Replace one bath a week with a shower. Baths use almost three times more water than a shower. You can make your shower even more efficient with a shower aerator.

If you would like even more advice on how to reduce your energy bills, you can apply for a free home visit from LEAP, in partnership with Gosport Borough Council. Our highly qualified energy advisors can help you with switching, you can even install LED lightbulbs and other energy saving measures as mentioned above, totally for free!

RECYCLING IN GOSPORT

Recycling is good for the environment and the economy, saving money and creating jobs. Most of the materials that we collect from you are reprocessed in the UK and are put to the best possible use to make new cans, tins, newspapers and plastic bottles.

Through recycling and energy recovery, Hampshire landfills less than 12% of household waste. Recycling reduces the need for raw materials such as trees, metal and oil which helps save energy and natural resources. Through recycling alone, Hampshire saves the equivalent in greenhouse gas emissions as taking 40,000 cars off our roads! So recycling is a really easy way to do something positive to help tackle climate change.

Our Streetscene department has two new waste and cleansing officers, Ian and Richard who will be working on boosting our recycling efforts in Gosport.

Ian and Richard will be out and about talking to residents, helping local community groups and liaising with the waste collection crew. Ian and Richard are also available to give talks on recycling, just call Streetscene on **08000 198 598**.

Here are some frequently asked questions about recycling in Gosport.

WHAT CAN I RECYCLE IN MY GREEN-LIDDED RECYCLING BIN?

You can recycle clean dry paper, cardboard; food and drinks cans and plastic bottles (please make sure you rinse out cans and bottles).

CAN I RECYCLE BOTTLE LIDS?

Sorry no, please removed lids and put them in your domestic black-lidded bin.

CAN I RECYCLE JUICE AND DRINKS CARTONS?

No, we cannot recycle these because the interiors are usually lined with foil or plastic. In Hampshire we do not have the correct equipment to separate the cardboard from the foil/plastic.

WHAT ABOUT OTHER PLASTIC?

In Gosport, we currently only have a market for plastic bottles.

WHAT ABOUT MARGARINE TUBS, YOGHURT POTS, FOOD TRAYS OR POLYSTYRENE? No, sorry we are unable to recycle these.

CAN I RECYCLE AEROSOLS?

Yes, just remove any plastic lids. However, we cannot take any aerosols marked with a skull and crossbones or a black cross on an orange background.

CAN I RECYCLE PIZZA BOXES?

Yes, if they are clean and dry.

CAN I RECYCLE SHREDDED PAPER?

Shredding paper reduces its quality and prevents it from being recycled into a high grade paper. Please take shredded paper to your local paper bank to be recycled into low grade paper.

CAN I RECYCLE GIFT WRAPPING PAPER?

Gift wrap doesn't always contain much paper and is often layered with foil and plastic which cannot be recycled.

WHAT ABOUT WALLPAPER?

Sorry, no because it is difficult to pulp and is often contaminated with paste.

WHAT HAPPENS TO MY RECYCLING?

Your recycling is taken to Portsmouth to be sorted and then transported to reprocessing plants. Paper products are de-inked, pulped and made into rolls of high-quality newsprint. Card and cardboard are made into new cardboard. Plastic bottles are used to make things like fleeces, drainage pipes and park benches and picnic tables. Cans are made into products including car parts, paper clips and new cans.

WHAT HAPPENS TO MY DOMESTIC RUBBISH FROM MY BLACK-LIDDED BIN?

It goes to Portsmouth to be incinerated (which is environmentally much better than landfill). This produces electricity which is fed into the National Grid.

WHY HAVE I GOT A RED TAG ON MY RECYCLE BIN?

This red tag means that there are items in your bin that we cannot recycle which are indicated on the tag. You need to remove them and either put them in your domestic bin or taken to the household waste and recycling centre, located in Grange Road, Rowner. Glass bottles and jars, as well as textiles and clothing can be recycled at recycling banks. Once these items are removed from your recycling bin, your recycling collections will resume.



WHAT IS SOCIAL PRESCRIBING?

Social prescribing enables GPs, nurses and other primary care professionals to refer people to a range of local, non-clinical services.

Social prescribing is sometimes referred to as community referral.



Recognising that people's health is determined primarily by a range of social, economic and environmental factors, social prescribing seeks to address people's needs in a holistic way. It also aims to support individuals to take greater control of their own health.

Social prescribing is designed to support people with a wide range of social, emotional or practical needs, and many schemes are focussed on improving mental health and physical well-being. Those that could benefit from social prescribing schemes include people with mild or long-term mental health problems, vulnerable groups, people who are socially isolated and those who frequently attend either primary or secondary health care.

There is emerging evidence that social prescribing can lead to a range of positive health and well-being outcomes. Studies have pointed to improvements in areas such as quality of life and emotional well-being, mental and general well-being, and levels of depression and anxiety.

Gosport Voluntary Action (GVA) delivers a number of life-changing Social Prescribing Projects including Surgery Signposting, VolunHeroes and Services for Older People delivered as part of the Close Encounters project.
