

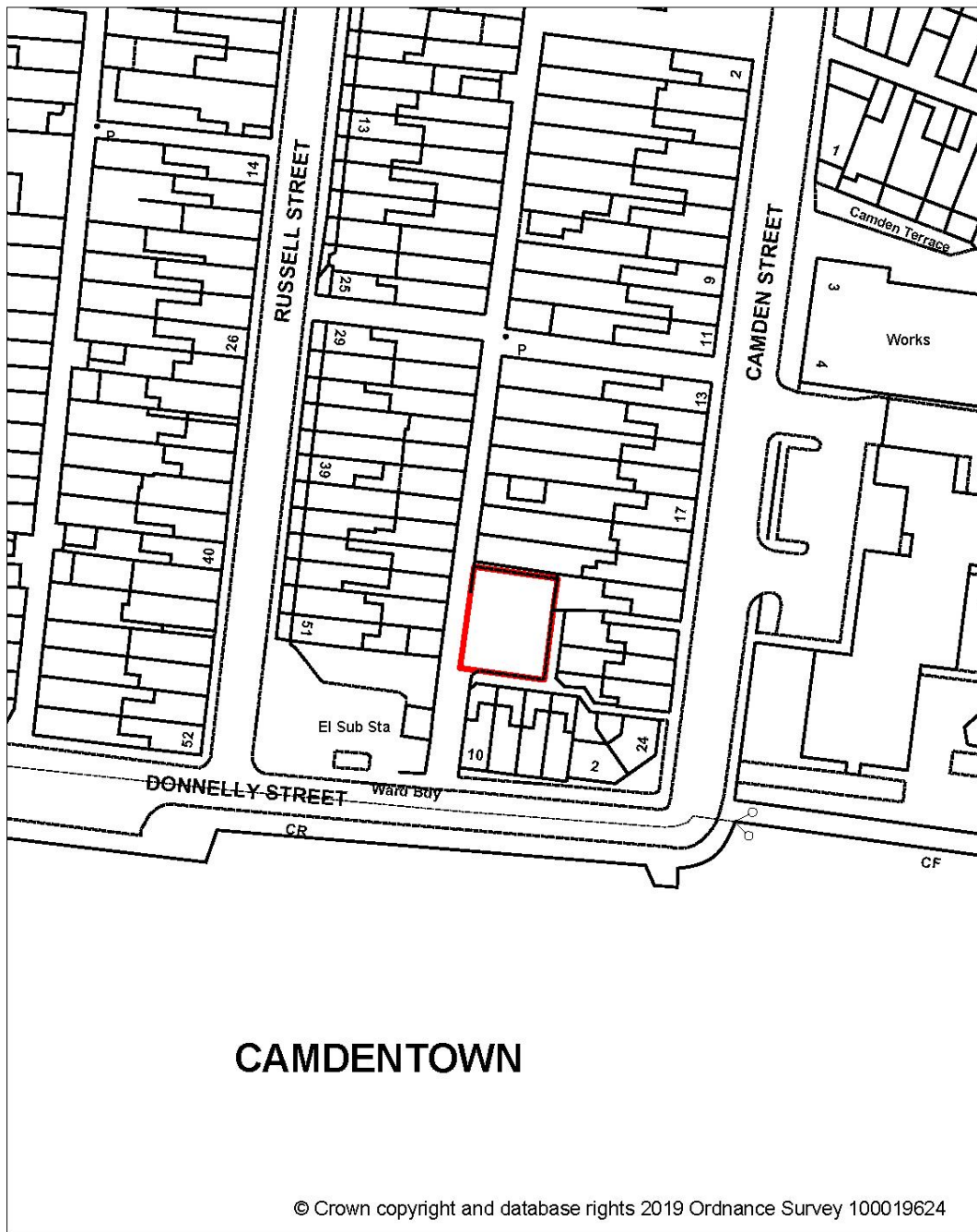

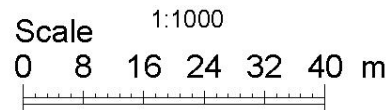

Concluding comments	The sites size and proximity to existing dwellings make it highly unlikely it would be viable for development. It is considered most appropriate that the site be retained to provide parking. Development on the site would likely have a negative effect on the established character of this area and lead to a loss of parking.
