

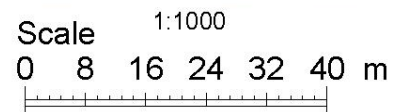
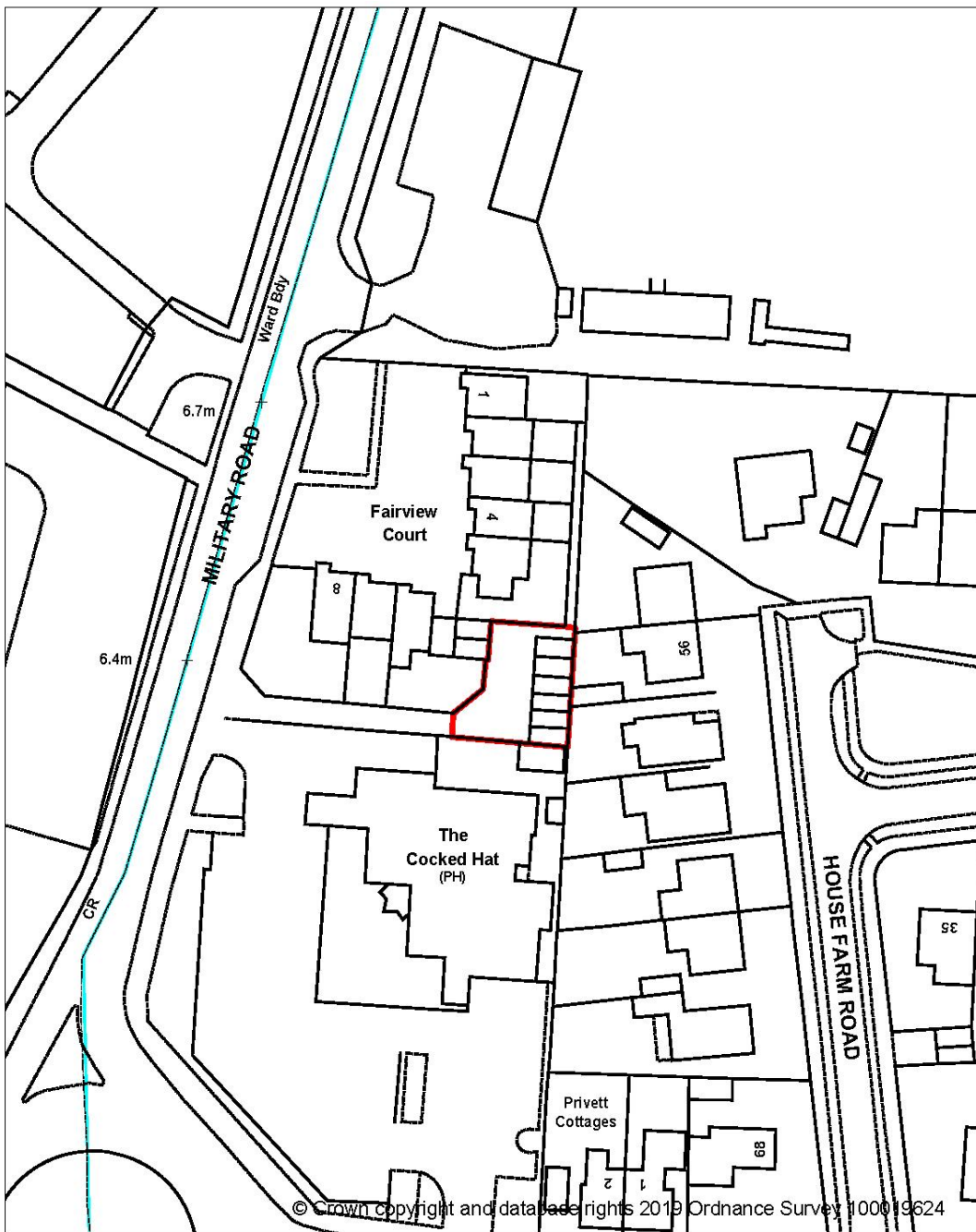

Concluding comments	The site has limited potential for significant residential development. As a result the site has been assessed as unable to accommodate 5 or more dwellings. There is potential for 1 or 2 dwellings, however local parking requirements and neighbouring amenity would have to be fully considered.
