<u>Purpose</u>

This report seeks the approval of the Community Board to make a public spaces protection order (PSPO) for the locality of Gosport town centre where aggressive begging, and alcohol / drug related anti-social behaviour (ASB) are prevalent and have a detrimental effect on the quality of life of those who live and work in or visit this area

Recommendation

- To consider the results of the consultation exercise in relation to this matter carried out between 25th August and 6th October 2017 as set out at Appendix A.
- ii. To approve a PSPO in the form of Appendix B to control ASB in public places within the area shown edged black in the accompanying plan (the "Restricted Area").
- iii. To delegate authority to the Borough Solicitor and Deputy Chief executive to take the necessary steps, including the publicity requirements, to implement the PSPO in the form of Appendix B.

1 Background

- 1.1 Aggressive begging, alcohol and drug related ASB (the "Activities") is becoming increasingly prevalent in Gosport High Street, The Bus Station, Falkland Gardens and The Ramparts. This conduct can have a detrimental impact on the quality of life for those who live and work in or visit Gosport town centre.
- 1.2 The Anti-Social Behaviour, Crime and Policing Act 2014 (the "Act") introduced new powers to tackle ASB in public places. A public place means any land or premises open to the public with or without payment whether expressly or impliedly (Public Place").
- 1.3 A PSPO provides for restrictions to be placed on behaviour that apply

to everyone in that public area (with the possible use of exemptions).

- 1.4 Breach of a PSPO restriction, without a reasonable excuse, is a criminal offence. The maximum penalty on conviction is a fine not exceeding £1,000. A fixed penalty of £100 within 14 days (or £50 in 7 days) can be offered as an alternative to prosecution, which if paid in full discharges a person's liability to criminal proceedings.
- 1.5 A PSPO is enforceable by Council officers authorised by the Chief Executive as well as police constables and police community support officers ("Authorised Officers").
- 1.6 A PSPO can last up for to three years, after which it must be reviewed. It may upon review be extended for an up to a further three years. There is no limit on how many times it may be renewed.
- 1.7 The Act allows the Council to make a PSPO if it is satisfied that the two conditions below are met (the "Legal Threshold")
 - a. Activities carried on in a public place have had or will have a detrimental effect on the quality of life of those in the locality; and
 - b. The activities are persistent or continuing and are unreasonable and the restrictions imposed by the PSPO are justifiable.
- 1.8 On 23rd August 2017 the Chief Executive approved for the purposes of consultation only a PSPO for all Public Places within the geographical area of Gosport town centre showed edged black on the plan at Appendix B.
- 1.9 The proposed prohibitions and requirements of the PSPO are as follows:

1.9.1 Prohibitions

- i). A person shall not engage in any conduct that causes or is likely to cause alarm, harassment or distress to a reasonable member of the public arising from the consumption of alcohol; or use of drugs; or begging;
- ii) A person shall not urinate or defecate in a Public Place otherwise than in a facility intended for that purpose.

1.9.2 Requirements

- i). A person shall comply with any direction of an Authorised Officer to cease using drugs; surrender any drugs or drug paraphernalia.
- II). A person in breach of clause 1.9.1 or 1.9.2i above or the *DPPO shall comply with any direction of an Authorised Officer to disperse

from a defined public space within the Restricted Area and not return there for up to 12 hours.

2 ASB Complaints

2.1 The Council and police have over the past 12 months received 35 complaints from members of the public and businesses about ASB in the Restricted Area linked to drug activity, alcohol consumption, and begging related conduct. Of these complaints 7 were alcohol related, 19 were drug related and 10 were begging related.

Alcohol related ASB

- 2.2 Street drinking in itself can be perceived as upsetting and threatening by other users of Public Places. It is particularly upsetting when the activity is accompanied by public disorder such as verbal abuse and other offensive behaviour.
- 2.3 The Council made a Designated Public Places Order in 2008, which covers all Public Places in the Borough except premises licensed for the sale or supply of alcohol ("DPPO").
- *2.4 The DPPO empowers the police to require a person to cease consumption of the alcohol and surrender alcohol containers.
- 2.5 It is a criminal offence for a person to, without reasonable excuse; fail to comply with a DPPO direction.
- 2.6 The DPPO will automatically convert into a PSPO on 20th October 2017 under the transitional provisions of the Act and remain in force until 20th October 2020.
- 2.7 The Council and the police are of the view that the DPPO does not go far enough in addressing the ASB arising from street drinking in the Restricted Area.
- 2.8 There is currently no control over those persons who, even after their alcohol has been confiscated, continue to engage in ASB in the Public Places or acquire more alcohol and return to the Public Place

2.9 Begging

There have been complaints of persons loitering in Gosport High Street outside cash machines and the ferry ticket machines asking for money from customers withdrawing cash or buying tickets. Some members of the public have stated they are intimidated by this activity and feel especially vulnerable when withdrawing money or getting cash out of their purse/wallet to buy a ferry ticket.

2.10 On occasions, when members of public have declined to give persons money or walked away, they have been met with verbal abuse.

2.11 Begging is a criminal offence under the Vagrancy Act 1824. However, there is no power for an Authorised Officer to issue a fixed penalty notice for the offence or to require a person to disperse from the area and not return there for a period.

Drug related activity

- 2.12 There have been a number of reports of persons openly injecting drugs in the Restricted Area. The behaviour of persons under the influence of drugs is unpredictable, especially if mixed with alcohol, and they may engage in verbal abuse or offensive behaviour.
- 2.13 Used needles deposited in Public Places pose a risk to public health from needle stick injury which can be associated with the transmission of blood borne pathogens such as hepatitis B virus (HBV), hepatitis C virus (HCV) and HIV associated with needle stick injuries.
- 2.14 In recent years the use of Psychoactive Substances (PS), known as legal highs, has increased. They are unpredictable in their effect, but are often mixed with hard drugs (heroin, cocaine, etc.) or alcohol. Intoxicated persons can become very aggressive, or very passive and vulnerable. Despite legislation to criminalise supply of PS in April this year, consumption remains legal.

2.15 Urination and defecation

The Council and the police have received complaints of persons, usually in drink or under the influence of drugs, urinating in the passageways of the Bus Station and the High Street.

- 2.16 This is mainly a problem at night-time when people leave establishments after drinking, although it can also take place during the day.
- 2.17 People who urinate in the street often do so against or near premises or in shop fronts, making it very unpleasant for the premises owners or residents who must clean up the mess, and for employees, visitors and customers who frequent the premises and have to walk through the mess. For many, it can also add to the perception of feeling unsafe.
- 2.18 It is not an offence under the criminal legislation or local byelaws to urinate or defecate in a Public Place.

3. Consultation

3.1 The Act requires the Council to carry out the necessary consultation before making a PSPO, which includes the chief constable of Hampshire Police and police crime commissioner and the public (PCC).

- 3.2 The Council have received an email from chief inspector Sharon Woolrich of Hampshire Constabulary confirming that the police fully support the proposals.
- 3.3 An online survey on the proposal to introduce PSPOs to control aggressive begging, street drinking and drug related activity was held between 25th August and 6th October 2017.
- 3.4 The survey produced over 300 responses, predominately from people living in the PO12 post code.
- 3.5 45.40 % of respondents stated that they had been affected by alcohol or drug related ASB in Gosport in the past 12 months with 7% unsure or preferring not to say.
- 3.6 48.57% of respondents stated that they had been affected by begging related ASB in Gosport over the past 12 months with 5% unsure or preferring not to stay.
- 3.7 The majority of respondents who had been affected by ASB stated that it had occurred in the High Street and Falkland gardens.
- 3.8 The comments from those respondents who indicated that the ASB had impacted on them can be summarised as
 - intoxicated persons engaging in rowdy and disorderly behaviour and using fouling language – taking over public spaces'
 - littering, including used needles, deposited on the ground;
 - members of the public, including young children and the elderly, have been approached in the High Street for money — on some occasions there has been verbal abusive when the member of the public has declined;
 - Members of the public feel distressed, intimidated by the behaviour and in some cases try to avoid the High Street.
- 3.9 51% of respondents stated that overall the PSPO will have a positive impact with 26% unsure. The comments from respondents who stated the PSPO would have no impact can be summarised as:
 - the police and council will not effectively enforce the PSPO so the ASB will just continue;
 - more needs to be done by the Council and other agencies to support the people that engage in this ASB address underlying issues such as homelessness, mental health etc;
 - criminalising the ASB or moving is not going to improve matter

in the long term

33.9% of respondents said that the PSPO should be limited to Public Places in the town centre. The majority of respondents were concerned about potential displacement Into other public places in the Borough should the application of the PSPO only extend as far as the town centre.

4. Rough sleepers

- 4.1 Rough sleeping in Public Places in the Restricted Area is not considered in itself to be ASB. There is no proposal to prohibit this activity under the PSPO.
- 4.2 The Council has the power under the common law to take action, where necessary and proportionate, to recover possession of any land or premises in its ownership, which is occupied without its consent. It is a matter for the owner or lawful occupier of any other land or premises to take their own action.

5. Support and Intervention

- 5.1 It is recognised that persons engaging in the Activities maybe vulnerable through being street homeless and / or having mental health or alcohol or addiction issues.
- 5.2 Council officers, as well as police and charities, regularly engage with rough sleepers on the street and offer them support in finding temporary accommodation and dealing with addiction or mental health issues.
- 5.3 The Council's hostels have space for up to 170 people, including homeless families and single people such as rough sleepers. In the last 12 months the council has provided long-term accommodation to 109 homeless applicants.
- 5.4 The Council chairs a group of local organisations which meets regularly to address issues related to rough sleeping.
- 5.5 The Council works in partnership with Two Saints, a local homelessness charity to support people who are homeless or threatened with homelessness.

Two Saints provide the following services:

- -a specialist outreach worker to engage with those sleeping rough on the street;
- -a local direct access hostel and other supported housing schemes which provide accommodation;

- -help and support with a range of issues such as accessing medical services and substance misuse teams and tenancy sustainment.
- 5.6 Tackling the ASB will not be achieved by enforcement action in isolation. A focus on Identifying vulnerable individuals who engage in the activities will continue to be part of the solution.

6. Alternatives to the PSPO

- 6.1 There are other enforcement options which target individuals responsible for ASB such civil injunctions, criminal behaviour orders and community protection notices. The nature of the ASB is such that the Activities are often undertaken by groups rather than individuals.
- 6.2 The police dispersal power is only exercisable on the direction of a police inspector. The dispersal power proposed under the PSPO is more flexible in that it will be conferred on Council officers as well as the Police and can be issued to individuals engaging in one or more of the Activities which cause harassment, alarm or distress to others

7. Proportionality of the proposed measures

- 7.1 The Council is not seeking a blanket prohibition on the consumption of alcohol or PS or begging in Public Places within the Restricted Area.
- 7.2 The prohibitions apply where the Activity causes or is likely to cause alarm, harassment, alarm or distress to any reasonable member of the public.
- 7.3 The power to require a person to disperse for breach of one or more restrictions on begging, alcohol consumption and drug use is limited to no more than 12 hours. This balances the need for swift action taken for the ASB to cease in order to protect the public with the rights of individuals to use public spaces.
- 7.4 The Council believes that on balance the interest of the community to enjoy public spaces without having to be subjected to the ASB described outweighs any impact on the persons affected by the restrictions.
- 7.5 The Council may offer the person an Acceptable Behaviour Contract ("ABC") rather than a fee, when issued with a fixed penalty notice (FPN).
- 7.6 The ABC is voluntary and non-binding and can include promises to make positive actions, such as accessing housing or addiction services and/or undertake restorative measures such cleaning up vomit etc (something that other authorities have introduced).
- 7.7 The Council will only prosecute in those cases where a FPN has been

issued and either the fee has not been paid or a requirement of an ABC has been breached, and prosecution is in accordance with the Council's generic enforcement policy.

7.8 The majority of the ASB complaints have occurred in the High Street and Falkland Gardens. It is therefore proportionate for the geographical area that the PSPO is to apply to be restricted to the locality of Gosport town centre and not beyond.

8. Risk Assessment

- 8.1 If ASB arising from the Activities is not tackled effectively it is likely to continue to have a detrimental effect on the quality of life for many people in Gosport town centre, and discourage people from using businesses and amenities within the town centre
- 8.2 The focus of the Council and the Police remains on supporting individuals identified as vulnerable through issues such as addiction. Enforcement will be targeted on those who unreasonably refuse help and assistance and engage in ASB.
- 8.3 The approach to enforcing the PSPO will be the key to their success in tackling the ASB within the Restricted Area. Any enforcement activity should be supported by community education to highlight the availability of support services. This approach has been agreed with the police.

9. Conclusion

- 9.1 The Council can be satisfied that the Legal Threshold to make a PSPO is met as evidence by the information set out in this report.
- 9..2 The results of the consultation exercise are such that the majority of respondents support the proposal.
- 9.3 It is, therefore, recommended the PSPO in the form of Appendix B be implemented without amendment.
- If the Community Board were to resolve to adopt a PSPO for the Restricted Area it would come into force on 17th November 2017.
- 9.5 The Council is required by the Act to publish a PSPO as made on its website and affix notices adjacent to the Public Places as it considers sufficient to draw the attention of any member of the public using that place it has been made.

APPENDIX A

Public Spaces Protection Order – Consultation report

1. INTRODUCTION

- 1.1 Gosport Borough Council has consulted the following persons or organisations on proposals for a new public protection order for Gosport town centre (the Consultees):-
 - 1.1.1 "Partners" means the Police, Highways Authority; Defence Infrastructure Organisation;
 - 1.1.2 "Stakeholders" means businesses and service providers, taxi operators and housing associations, welfare and outreach organisations;
 - 1.1.3"The Public" means a Gosport resident, person who visit or work in Gosport.
- 1.2 The consultation period commenced on 25^t August 2017 and ended on 6th October 2017.
 - 1.3This report sets out the background to the consultation, how it was undertaken, the number of responses received, the results, and analysis.

2. BACKGROUND

- 2.1The Council has the power to make public spaces protection orders (PSPOs) for public spaces in its area. Public space is defined as any place accessible by the public with or without payment such as the bus station and pontoon.
- 2.2The purpose of a PSPO is to control anti -social behaviour (ASB) in public spaces arising from certain activities, which is having a detrimental effect on the quality of life of those living and working within the local area. It is an offence for a person to, without reasonable excuse, to breach or fail to comply with a PSPO restriction.
- 2.3Since the beginning of the year there has been an increase in the number of complaints made to the Council and police of ASB in Gosport town centre in particular the High Street, Bus Station, Falkland Gardens and The Ramparts. The ASB reported is in many cases linked to the consumption of alcohol, drug use, aggressive begging (the "Activities").
- 2.4The Council made a designated public place order in 2009 for all public places in the Borough other than licensed premises. The DPPO confers a discretionary power on the police to address street or nuisance drinking by requiring a person to cease consumption of alcohol and surrender any alcohol or alcohol containers.

- 2.5 The Council is considering adopting a new PSPO that covers all public spaces within the area shown edged black on the plan at x, which includes the High Street, Bus Station, Falkland Gardens and the Ramparts (the "Restricted Area").
- 2.6The proposals are as follows:
 - 2.6.1 To prohibit
 - -Any conduct in the Restricted Area that causes or is likely to cause alarm, distress or harassment to any reasonable member of the public linked to any of the Activities
 - -Urinating or defecating in the Restricted Area other than in a toilet 2.6.2To require
 - -a person in breach of 2.5.1 to stop using drugs; surrender any drugs or paraphernalia if directed by an *Authorised Officer to do so.
 - -a person in breach of 2.5.3 or the DPPO to disperse from a defined public space and not return for a period of up to 12 hours if required to do so by an *Authorised Officer
 - *Officer authorised by chief executive or Police constable
- 2.7 The Chief Executive has agreed that there should be consultation with Partners, Stakeholders and the Public on the proposals before a final decision is taken whether to adopt the PSPO.

3. PRINCIPLES OF CONSULTATION

- 3.1 The Council takes its duty to consult with Partners, Stakeholders and the Public on the proposals for a new PSPO for the Restricted Area very seriously.
- 3.2 It recognises that ASB will continue to have detrimental effect on a community if it cannot be properly addressed through positive intervention or existing enforcement tools.
- 3.3 Blanket restrictions on activities in public spaces may have the unintended consequence of penalising the law abiding majority from enjoying public spaces. The Council is mindful that many people who come to its attention for ASB in the Restricted Area may themselves be vulnerable through addiction, housing or health issues and criminalising them may not tackle the underlying issues driving the ASB.
- 3.4 The Council is therefore, committed to consulting as widely as possible with all groups and persons that may be affected by the proposals for a new PSPO so it can make a fully informed and balanced decision as to whether it is satisfied the legal threshold for a PSPO is met.

4. APPROACH

- 4.1 The approach for this consultation was to use a survey, which respondents could quickly and easily complete online.
- 4.2 This method enabled an appropriate amount of explanatory and supporting information to be included in a structured questionnaire, helping to ensure that Consultees are aware of the background and context to the proposals.
- 4.3 A notice was posted on the council website with a link to the survey on the notice and survey questions are produced at schedule 1.

5. PROMOTION AND COMMUNICATION

- 5.1 The consultation was promoted in the following ways:
 - 5.1.1Notice published in the Hampshire Chronicle
 - 5.1.2 Article in "The News"
 - 5.1.3Posters in the main Town hall reception area with details of the consultation
 - 5.1.4 Letter sent to Partners and Stakeholders
- 5.2 The Council's Facebook and Twitter accounts were used to signpost the Public and Stakeholders to the consultation information and questionnaire.

6. CONSULTATION RESPONSES

- 6.1 The Council have received an email from chief inspector Sharon Woolrich of Hampshire Constabulary confirming the police fully support the proposals. The said email is produced at schedule 2.
- 6.1 The survey was completed by over 300 respondents

7..DEMOGRAPHIC

- 7.1 88.27% of the respondents were local residents.
- 8. SURVEY RESULTS

- 8.1Question In the past 12 months have you been affected by alcohol or drug related ASB in Gosport?
 - 8.1.1 Yes 45.4% of respondents
 - 8.1.2 Don't Know / Prefer not to say 7.62% of respondents
 - 8.1.3 No 46.98% of respondents
 - 8.2. Question In the past 12 months have you been affected by begging related ASB in Gosport?
 - 8.2.1Yes 48.57
 - 8.2.2 Don't Know / Prefer not to say 5.08%
 - 8.2.3 No 46.35%
 - 8.3 If respondents answered yes to questions 8.1 or 8.2 they were able to
 - 8.3.1.specify the location of the incident

More than half of the respondents who specified a location stated the ASB occurred at the High Street or Bus Station or Falkland Gardens

8..3..2 specify how the incident has impacted them

Comments can be summarised as:

- Intoxicated persons engaging in rowdy and disorderly behaviour and using fouling language – taking over public spaces
- Littering, including used needles, deposited on the ground
- Members of the public, including young children and the elderly, have been approached in the High Street for money — on some occasions there has been verbal abusive when the member of the public has declined
- Members of the public feel distressed, intimidated by the behaviour and in some cases try to avoid the High Street
- 8.4 Question Overall, what impact do you think having the PSPO in place will have?
- 8.4.1 51.75% of respondents said positive impact
- 8.4.2 26.03% of respondents said didn't know
- 8.4.3 22% respondents said no impact
- 8.5 If respondents said negative impact they were asked to say why
- 8.5.2 No impact comments can be summarised as
 - The police and council will not effectively enforce the PSPO so the ASB will just continue

Introduction

The number of complaints to Gosport Borough Council (GBC) and the Police of Anti-Social Behaviour (ASB) in Gosport High Street, Falkland Gardens, the Bus Station and surrounding areas arising from the consumption of alcohol, the use of drugs and begging has increased significantly over recent months.

Complaints include:

- Persons loitering by cash and ticket machines and asking members of the public for money
- · Persons openly injecting drugs
- Discarding used needles which may pose a risk to members of the public
- Persons in drink being verbally abusive to passers by
- · Urinating in the street

In 2008 GBC successfully applied for a Designated Public Place Order (DPPO) for the borough to address ASB linked to the consumption of alcohol in public places. The order gives a Police Officer the power to require a person to cease the consumption of alcohol and surrender any alcohol or alcohol container if asked. It is an offence for a person to, without reasonable excuse, fails to comply with this request.

On the 20 October 2017 this DPPO will automatically become a PSPO. However, under the Anti-Social Behaviour Crime and Policing Act 2014 councils have the power to introduce a PSPO which deals with a particular nuisance or problem in a defined area that is detrimental to the local community's quality of life, by imposing conditions on the use of that area which apply to everyone.

A PSPO is designed to make public spaces more welcoming to the public and communities by stopping individuals or groups committing ASB in a public space. GBC is therefore asking members of the public if they should implement a PSPO to restrict ASB which impacts negatively on people's quality of life. Under the proposed PSPO it would be an offence, without reasonable excuse, for a person in a proposed area to:

- engage in conduct causing harassment, alarm or distress to any reasonable member of the public arising from the consumption of alcohol or use of drugs or begging
- fail to on request by an Authorised Person to cease consuming alcohol or drugs and surrender any alcohol or drugs containers or drug paraphernalia.
- fail to disperse from a specific public place and not return for up to 12 hours on request by an Authorised Person.

The views of businesses, residents, visitors, partner agencies and other stakeholders is important to GBC and as such a period of consultation will run for six weeks from 25th August 2017 to 6th October 2017. The Community Board at a public meeting to be held at at 6pm on 17th October 2017 Gosport Borough Council Town Hall will have regard to the results of the consultation exercise and make the final decision as to whether the PSPO proposed should be adopted. If adopted the PSPO will come into force on 17th November 2017.



APPENDIX B - DRAFT PSPO

Section 59 The Anti-Social Behaviour, Crime and Policing Act 2014 (the "Act")
The Borough of Gosport Town Centre Public Spaces Protection Order 2017

Gosport Borough Council (the "Council") having been satisfied that the conditions set out at section 59 of the Act are met upon the following detrimental activities being carried on in the Restricted Area:

- anti-social behaviour linked to begging,
- anti-social behaviour linked to alcohol or drug use, and
- urinating ordefecating

The Council hereby makes the following Public Spaces Protection Order for its area:

1. Interpretation

- 1.1 "Authorised Person" means a Council officer authorised by the chief executive of the Council or police constable or police community support officer, who must present their authority upon request;
- 1.2 "DPPO" means the designated public places order made by the Council in 2008 for all land or premises open to the public in the Borough of Gosport (other than consumption of alcohol on premises authorised for the sale or supply of alcohol)
- 1.3 "Public Place" means any place to which the public or any section of the public has access, on payment or otherwise, as of right or by virtue of express or implied permission;
- 1.4 "Restricted Area" means any Public Place in the area shown edged black on the plan at **Schedule 1** to this order.

2. Restrictions

- 2.1. No person shall in the Restricted Area engage in any conduct capable of causing or likely to cause harassment, alarm or distress to any reasonable member of the public arising from the consumption of alcohol; the use of drugs; or begging.
- 2.2 No person shall in the Restricted Area fail or refuse to comply with any requirement of an Authorised Person to cease using drugs; or surrender any drugs, or any drug containers, or any drug paraphernalia in their possession.
- 2.3 No person shall urinate or defecate in the Restricted Area otherwise than in a facility intended for such use.

2.4 No person who is:

- (a) in breach of paragraphs 2.1 or 2.2 or 2.3 above; or
- (b) in breach of the requirement to cease consumption of alcohol or surrender any alcohol containers to an Authorised Person under the DPPO

shall


- (a) refuse or fail to disperse from a defined Public Place in the Restricted Area; and
- (b) return to the defined Public Place in the Restricted Area within 12 hours of being required to disperse


if required to do so by an Authorised Person.

3. Penalty

3.1 It is an offence contrary to section 67 of the Act for a person without reasonable excuse to fail to comply with the restrictions in paragraphs 2.1 or 2.2 or 2.3 or 2.4 or 2.5 above. A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding £1,000.

This order shall remain in force until 2020

Section 59 of the Anti-social Behaviour Crime and Policing Act 2014 (the "Act") gives the council the power to make a public space protection order ("PSPO"). A PSPO restricts activities, subject to any exemptions, in specified places open to the public in its area, which are linked to anti-social behaviour (ASB). It is a criminal offence for a person to, without reasonable excuse, to breach a PSPO restriction. A council officer authorised by the chief executive or police constable or police community support officer may enforce the PSPO ("Authorised Person").
The council must be satisfied that the legal threshold for making a PSPO is met: i.e. the activities are having a detrimental effect on persons living in the locality, and the restrictions proposed are reasonable. The council must consult with the public, partners such as

The council and police have had a significant amount of reports since the beginning of 2017 from the public and businesses of persons engaging in aggressive begging, and anti-social behaviour linked to alcohol consumption or drug use (ASB) in places accessible by the public in the High Street, Bus Station and Falklands Gardens (the "Town Centre").

the police, and stakeholders and have regard to the responses before a PSPO is adopted.

The council proposes to adopt a PSPO limited to places accessible by the public in the Town Centre, which restricts the following:

activities:

- 1.No person shall engage in any conduct causing or likely to cause harassment, alarm or distress to any reasonable member of the public arising from alcohol consumption or drug use; or begging.
- 2. No person shall refuse or fail to comply with a requirement by an Authorised Person to cease consumption of alcohol or drug, surrender any alcohol containers or drugs or drug paraphernalia in their possession.
- 3. No person in breach of paras 1 or 2 above shall refuse or fail to comply with a requirement by an Authorised Person to disperse from a defined public place and not return for a period of up to 6 hours

The council has informally canvassed the view of the Police and other partners on the proposals, whom have indicate they are broadly supportive of the measures.

The Chief Executive will this month consider a report recommending that he authorises the Council to adopt a PSPO for the Town Centre subject to consultation.

If the chief executive agrees the council will consult:

the public on the proposals by publishing a notice on its website with a link to an online questionnaire for completion, or comments to be made in writing or by email. The consultation will also be publicised on social media and the local press.

the Police, Highway Authority, and stakeholders such as Two Saints, Avalon, and CAP A notice will be sent to partners such as The consultation period will be for 6 weeks.

The community board will at its meeting on 8th November consider the Reponses to the consultation and decide whether to adopt the proposed PSPO. If adopted the PSPO could be in force on 1st January 2018.

2a. Describe the main aim or purpose of this item? Who will it benefit? Why is it needed?

Alcohol related ASB

Complaints have been made to the council and police by members of the public and businesses of persons loitering in the Restricted Area, in particular the High Street, Falklands Gardens, the Bus Station drinking alcohol. This activity in itself is it perceived as upsetting and threatening by other users of public spaces. It is particularly upsetting when the activity accompanied by public disorder such as verbal abuse and other offensive behaviour.

The council made a Designated Public Places Order in 2008 (DPPO) which covers all places accessible by the public in the Borough except premises licensed for the sale or supply of alcohol. This will convert to a PSPO on 20th October 2017 and remain in force until 20th October 2020. This is enforced by the Police and has been proportionately applied during the 9 years it has been in force, significantly reducing the problem that Gosport used to have.

However the council and the police are of the view that the DPPO does not go far enough in addressing the ASB arising from street drinking in the Restricted Area.

There is no control over those persons who, even after their alcohol has been confiscated, continue to engage in ASB in the public place or acquire more alcohol and return to the public place in drink.

Aggressive Begging

There have been complaints of persons loitering in the High Street outside cash machines the ferry ticket machines asking customers withdrawing cash or buying tickets for money.

Members of the public have stated they are intimidated by this activity and feel especially vulnerable when withdrawing money or

getting cash out to by a ferry ticket.

Drug related ASB

There have been reports of persons openly using drugs in public places is Gosport Town Centre by injection.

The possession and supply of controlled drugs is a criminal offence. Criminal activity such as theft and violence is associated with these offences. The behavior of person under the influence of drugs is unpredictable, especially if mixed with alcohol and they may engage in verbal abuse or offensive behavior

Drug paraphernalia is often discarded on the ground in the Restricted Area, which is unsightly. Used needles deposited in public places are a health hazard as there is a risk of needle stick injury and transmission of blood borne pathogens such as hepatitis B virus (HBV), hepatitis C virus (HCV) and HIV associated with needle stick injuries.

In recent years the use of Psychoactive Substances (PS) legal highs has increased. They are unpredictable in their effect, but are often mixed with hard drugs (heroin, cocaine, etc.) or alcohol. Intoxicated persons can become very aggressive, or very passive and vulnerable. Despite legislation to criminalise supply of PS's in April this year, consumption remains legal.

The persons who engage in the ASB are often themselves vulnerable through being street homeless or have alcohol or drug addictions or mental health issues. The council's focus is on working with the agencies to assist persons accessing temporary accommodation and addressing underlying issues which may be a barrier in them finding more settled accommodation. Sadly there are some who do not wish to engage in this process and continue to cause ASB.

In these situations the council requires effective enforcement measures to curb the ASB so members of the public can freely access the public places without fear. Existing measures such as the criminal law, criminal behaviour orders and injunctions are aimed at individuals rather than groups but are of limited effect as they do not deal with the ASB on the spot.

- foster good relations between people from different groups.

There is no blanket restriction proposed on the consumption of alcohol, or use of PS, or begging

The Council is not targeting rough sleepers. Rough sleeping is not in itself anti-social. The Council has the power under the common law to take action where it is necessary and proportionate to recover possession of land or premises in its ownership which is subject to an unauthorised encampment,

It does not follow that the Council will always prosecute a person for contravening a restriction or prohibition of a PSPO. The Council must have regard to its generic enforcement policy in deciding whether it's in the public interest to prosecute. The age and circumstances of the offender and whether there are any mitigating or aggravating features are relevant considerations in assessing the public interest .The Council may decide to offer a person an Acceptable Behaviour Contract with positive conditions to engage in support Alternatively it may issue a fixed penalty notice for the offence, which if paid in full within the prescribed period has the effect of discharges that person's liability to criminal proceedings. It may also decide to issue a person with a formal caution for the offence.
