# **PURPOSE OF REPORT**

The report consolidates the effect of the Council's approved budget, Collection Fund surplus and precepting authority requirements in order to establish the necessary council tax levels to apply in the Borough of Gosport for 2008/2009.

#### **RECOMMENDATIONS**

As contained in the appendices to the report (Appendix A for a £12,608,000 budget or Appendix B for a £12,707,000 budget).

#### 1.0 BACKGROUND

- 1.1 The Council are required to set the levels of Council Tax for the Borough for 2008/2009 on behalf of the Council as billing authority. The tax level results from the precept requirements of Hampshire's County Council, Police Authority and Fire & Rescue Authority, the Council's approved budget and local tax collection balances.
- 1.2 No comments relating to the budget level have yet been received as a result of the statutory consultation process with major business ratepayers.
- 1.3 Whilst the Council agreed a general fund budget of £12,608,000 at its meeting on 6 February 2008, there is a proposal to amend this to £12,707,000 on the Council agenda for 25 February 2008. The appendices deal with each option in turn and only the appropriate one should be considered and approved, dependent on whether the proposed amendment to the budget is agreed.

#### 2.0 COLLECTION FUND SURPLUSES & DEFICITS

- 2.1 Surpluses or deficits from Council Tax collection are assessed annually in order that corrective action can be taken in setting future Tax levels. They form part of the figure contained in recommendation 5.2(d). The figure of £55,000 represents Gosport's share of surpluses on the council tax collection fund as considered as part of the approved Budget.
- 2.2 The Table 1 in each appendix shows how these balances plus the requirements of the precepting authorities affect the amount to be collected from Council Tax and Table 2 shows the resulting tax levels:

#### 3.0 BILLING ARRANGEMENTS 2008/2009

3.1 Despatch of Council Tax bills will commence early in March 2008 and be completed shortly afterwards.

The 2008/2009 total figures represent an increase of 4.47% over 2007/2008, Gosport's element having increased by 1.9%

- 2. By virtue of the budget approved by Council on the 06 February 2008 the following amounts be now calculated by the Council for the year 2008/2009 in accordance with Sections 32 to 36 of the Local Government Finance Act 1992:-
  - (a) £49,691,690 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)(a) to (e) of the Act.
  - (b) £37,083,690 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)(a) to (c) of the Act.
  - (c) £12,608,000 being the amount by which the aggregate at 5.2(a) above exceeds the aggregate at 5.2(b) above, calculated by the Council, in accordance with Section 32(4) of the Act, as its budget requirement for the year.
  - (d) £7,279,031 being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed non-domestic rates, revenue support grant and additional grant; increased by the amount of the sums which it estimates will be transferred in the year from its collection fund to its general fund in accordance with Section 97(3) of the Local Government Finance Act 1988 (Council Tax Surplus).
  - (e) £194.26 being the amount at 5.2(c) above less the amount at 5.2(d) above, all divided by the amount at 5.1(a) above, calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its council tax for the year.
