### **Introduction**

Seven meetings of the full committee were called during the course of the municipal year, including two extraordinary meetings. There were also several meetings of a number of working groups.

### **Report**

The Committee published the following reports:

#### **1.0 Supplementary Report of the Medical and Accident Services Working Group**

- 1.1 A working group chaired by Cllr Forder authored this report which followed on from the previous year. It dealt with South Coast Ambulance Service's proposals for a Resource Centre which has implications for the future of Gosport Ambulance Station. The report supported the planned proposals and was adopted at the full Council meeting of 11 July, 2012

#### **2.0 Armed Forces Covenant**

- 2.1 This very substantial report was the result of the work of a working group chaired by Cllr Kimber. Following the collection of extensive evidence from representatives of the local community and the armed forces the report proposed the creation of an Armed Forces Community Covenant. This was adopted at the meeting of the full Council of 3 October, 2012. The Commanding Officers of HMS Sultan and 33 Field Hospital, the Chief Executive and the Mayor of Gosport Borough Council, Gosport Voluntary Action's Chief Executive and a representative of Gosport Citizen's Advice Bureau signed the covenant document at a ceremony conducted during the Remembrance Day service at the War Memorial Hospital on 11th November 2012.

### **3.0 Progress Report of the Overview and Scrutiny Medical Services Working Group**

3.1 During the course of the year the Medical Services Working Group, chaired by Cllr Forder, held three further evidence gathering sessions

- i) 19 June with the Chief Executive and Director of Communications and Public Engagement for University Hospital Southampton NHS Trust
- ii) 8 October with the Chairman and Chief Officer (Designate) of the Fareham and Gosport Clinical Commissioning Group CCG .
- iii) 11 October with Simon Holmes (Medical Director of Queen Alexandra Hospital) and Graham Sutton (Consultant Vascular Surgeon).

Evidence was also sought through an exchange of letters with Diabetes UK, the Stroke Association, the Renal Association, Cancer Research UK. There was also correspondence with the Chief Executive of Southampton, Hampshire Isle of Wight and Portsmouth (SHIP) PCT Cluster.

The report recorded general satisfaction with the progress made in ensuring the future viability of vascular surgery services at Queen Alexandra Hospital and the establishment of the Fareham and Gosport CCG.

We are pleased that the Council is now represented on the Fareham and Gosport CCG.

### **4.0 Promotion of the Borough**

4.1 This report was the work of a working group chaired by Cllr Jacobs. It recommended that the responsibility for social media networks be under the control of one officer at Gosport Borough Council to ensure consistency of message and technological advance. The Chief Executive and the Head of Information Technology (IT) Services reported back to the full Committee at its meeting on 14 March 2013.

4.2 The Head of IT Services will act as the single point of control and contact. Officers will also explore ways of developing further social media to improve the dissemination of information and will report to the Committee in due course.

### **5.0 The Committee's other work:**

5.1 The Committee received the Council's Single Equality Annual Report.

5.2 The Committee received updates on progress with the renegotiation of the Dial-A-Ride contract and other associated recommendations

made in its report of the previous year.

- 5.3 The Committee, in the shape of Cllr Gill, made arrangements for committee members and other councillors to visit local secondary schools with the purpose of learning more about their successes and challenges now and in the future. Bay House School and Sixth Form, St Vincent College and Brune Park Community School have already been visited. Bridgemary Community School will be visited in the near future.

#### **6.0 Chairman's comments**

- 6.1 The Chairman remains indebted to those members who have served on the Committee, particularly those who have given up substantial time to serve or lead working groups.
- 6.2 He is also grateful to those officers who have worked hard to ensure the success of the Committee.
- 6.3 Last, but by no means least, particular and fulsome thanks is due to the late Dr. Bob Pennells, who worked with the Committee with such enthusiasm in the last couple of years of his life with the sole aim of improving the services available to the citizens of the Borough to whom he devoted his working life.

**Purpose**

To advise Council of a planning application submitted to Fareham Borough Council which involves land in the area of Gosport Borough Council and to make arrangements for its determination.

**Recommendation**

That the Council pursuant to pursuant to Section 101 of the Local Government Act 1972 Gosport Borough Council delegates to Fareham Borough Council its function to receive and determine any planning application for the provision of an access to a college to be located on adjoining land situated in the Borough of Fareham in respect of the land edged black on the plan at Appendix 1.

**1.0 Background**

- 1.1 The borough boundary runs across the Enterprise Zone at Daedalus and this necessitated the 2 separate applications for Outline Planning Permission recently considered by the Council.
- 1.2 Proposals have recently been brought forward for a college on land within Fareham Borough Council's area although access to the college includes land within Gosport.

**2.0 Report**

- 2.1 A planning application for the access to the proposed college and drainage attenuation tanks has recently been submitted to Fareham Borough Council. This application includes land in Gosport as shown hatched black on the plan attached as Appendix 1 to this report.

- 2.2 Given the amount of land involved in Gosport's area and the proposed development the Applicant has asked whether it would be possible for this application to be made to and determined by Fareham Borough Council rather than them having to make 2 separate applications.
- 2.3 The Head of Development Control has considered the details of the application and does not believe that there are any matters which the Council would object to and that it is appropriate to agree to the Applicants request.

### **3.0 Risk Assessment**

- 3.1 Given the Head of Development Control's comments there is no risk in Fareham approving an application this Council would oppose.
