# **Purpose**

As the licensing authority for Hackney Carriage and Private Hire drivers and vehicles, this council is able to apply reasonable conditions to the licences that it grants. This report identifies a request to change Gosport Borough Councils Hackney Carriage and Private Hire Conditions Private Hire Conditions to permit taximeters to be installed in Private Hire Vehicles

## Recommendation

The conditions applied by this Council to Private Hire Vehicles are amended as indicated in this report. It is recommended that the Licensing Board removes the condition 35 relating to Private Hire Vehicles that states "There shall not be installed in such vehicles a taximeter " and replace it with conditions allowing a taximeter to be installed in a Private Hire Vehicle.

# 1 Background

- 1.1 There is no power in under any statute allowing a local authority to set the fares charged by private hire vehicles. It is entirely a matter for negotiation between the hirer and the operator as to the fare that will be charged. However that provision can be limited if a meter is fitted to the vehicle
- 1.2 There is no power that enables a local authority to require a meter to be fitted, but if one is fitted then the meter must comply with Section 71 Local Government (Miscellaneous Provisions) Act 1976
- 1.3 Section 71 Local Government (Miscellaneous Provisions) Act 1976 states :-
  - (1) Nothing in the Act shall require any private hire vehicle to be equipped with any form of taximeter but no private hire vehicle so equipped shall be used for hire in a controlled district unless such taximeter has been tested and approved by or on behalf of the district council for district or any district council by which a vehicle licence in force for the vehicle was issued.
  - (2) Any person who-

- (a) Tampers with any seal on any taximeter without lawful excuse: or
- (b) Alters any taximeter with intent to mislead; or
- (c) Knowingly causes or permits a vehicle of which he is a proprietor to be used in contravention of subsection (1) of this section.

Shall be guilty of an offence.

Section 71 of the Local Government (Miscellaneous Provisions) Act 1976 requires the Local authority to test and approve the taximeter but does not empower the local authority to set a fare.

# 2 Report

- 2.1 On 10<sup>th</sup> May 2012 a letter was received form Mr. Philip COX, the Proprietor of "Hardway Cabs", seeking permission to install a meter into a licensed private hire vehicle. Currently in the Gosport Borough Council Hackney Carriage and Private Hire Conditions Revised: July 2008 relating to Private Hire Vehicles condition 35 states, "There shall not be installed in such vehicles a taximeter".
- 2.2 Mr. Philip COX has stated in his letter that if he was granted permission he will calibrate the taximeter installed in his Private Hire Vehicle to the tariff set by Gosport Borough Council for Hackney Carriage taximeters.
- 2.3 Mr. Philip COX has correctly stated in his letter that a Hackney Carriage a taximeter calibrated to the Gosport Borough Council tariff is the maximum fare that may be charged for a journey. The taximeter will be positioned in the vehicle to be in full view of the customer and displays the updating tariff through out the journey.
- 2.3 Mr. Philip COX is the Proprietor of Hardway Cabs and currently operates one licensed Private Hire Vehicle. He has applied to the Local Authority to become a Private Hire Operator in his own right and operate under the trade name "Hardway Cars".
- 2.4 Mr. Philip COX has correctly stated that Portsmouth, Fareham, and Southampton permit taximeters in Private Hire Vehicles. There is no legal or operational reason why Private Hire Vehicles licensed by this Council cannot be approved to be equipped with taximeters. Provided the Gosport Borough Council Hackney Carriage and Private Hire Conditions, as amended, will be complied with at all times.

## 3 Risk Assessment

3.1 It is important to ensure that this Council only licences vehicles that are safe and fit for the purpose of operating as Private Hire Vehicles.

- 3.2 In order to ensure the safety of the travelling public conditions imposed by this council must be appropriate and relevant.
- 3.3 Conditions should not be seen as a barrier to trade.
- 3.4 The adoption of the proposed revised Conditions will better inform the travelling public.

# 4 Conclusion

- 4.1 If the Licensing Board approves Mr. Cox's request to install a taximeter in his licensed Private Hire Vehicle. The Gosport Borough Council Hackney Carriage and Private Hire Conditions as they apply to Private Hire Vehicles must be revised by the removal Condition 35 "There shall not be installed in such vehicles a taximeter".
- 4.2 The following two new conditions should be inserted into The Gosport Borough Council Hackney Carriage and Private Hire Conditions as they apply to Private Hire Vehicles.

## 35 Taximeter

A Taximeter, if fitted, must be tested and be of an approved type by or on behalf of the Council.

# 35 (A) Tariff Card

At all times a tariff card will be clearly displayed, where it can be seen by any passenger, giving the tariff applied by the operator through whom the vehicle is operated

I wish to address the Licensing Board at the meeting on the  $6^{\text{th}}$  June 2012 on the following point.

To install a meter into a private hire vehicle.

Condition 35 of Gosport Council Private Hire terms states "There shall not be installed in such a vehicles a taximeter".

However the in Fareham, Portsmouth, Southampton and Eastleigh the council permits both meters and unmetered cars.

Also a meter is the maximum fare that may be charged and therefore it is in full display to the customer from the time they enter the car till the time they leave and this is a fare way to operate.

As there is no power by Gosport Council or any Council to set Private hire fares I feel that by installing a meter I can set this to my company rate which would be in line with that set by Gosport Council meters.

# Page 5 of the Gosport Borough Council Hackney Carriage and Private Hire Conditions Revised: July 2008 relating to Private Hire Vehicles. Showing Condition 35.

#### Licence conditions revised 10/07/08

27. A plate holder shall maintain a record in a form satisfactory to the Council and enter therein the date and time of commencement and cessation of work of each driver each day and shall produce such record on request to any authorised officer of the Council or to the police and shall maintain such records for at least one calendar year.

#### **Taximeters**

- 28. All vehicles must be fitted with taximeters approved by the Public Carriage Office.
- 29. Any authorised officer of the Council or any constable shall have power to inspect and test for fitness any taximeter affixed to a vehicle. If the officer or constable is not satisfied as to its fitness they may by notice in writing require the proprietor of the vehicle to make its taximeter available for further inspection and testing. In the meantime the vehicle licence will be suspended until such time as the officer or constable is so satisfied.
- 30. If the authorised officer or constable is not satisfied within a period of two months, the licence shall be revoked. They shall give the proprietor notice of the grounds on which the licence has been revoked within 14 days of that action.
- Officers carrying out the inspection of taximeters do so as an act of enforcement and shall not be liable to pay any fare.

#### Private Hire Vehicles

- "Pre-booking only" stickers, 2.5 centimetres (1 inch) in height, should be displayed on each of the passenger doors.
- 33. There shall not be displayed on or above the roof of any vehicle any sign, notice, mark illumination or other feature which may suggest that the vehicle is a taxi.
- 34. The vehicle should not be of such a design and appearance as to lead any person to believe that the vehicle is a taxi (the vehicle designs which come into this category are Metrocab, LTI, Fairway and FX4W). If the Plateholder intends to operate a vehicle other than a saloon car or estate car he/she should first check with the Council's Licensing Officer.
- 35. There shall not be installed in such vehicles a taximeter.
