60. EXCLUSION OF THE PUBLIC

61. GOSPORT PENALTY POINTS SCHEME REVIEW OF HACKNEY CARRIAGE VEHICLE DRIVER LICENCE.

Consideration was given to an exempt report of the Environmental Services

Manager advising that a Hackney Carriage Vehicle Driver Licence Holder had accumulated 12 penalty points in a rolling 12 month period as set out in Gosport Borough Council Penalty Points Scheme Paragraph 2 Action Levels and recommending the review of the Licence held.

The report was exempt from publication as the public interest in maintaining the exemption outweighed the public interest in disclosing the information by reason that it contained personal information that was not considered appropriate to be released to the public.

RESOLVED: That

a) the Hackney Carriage drivers licence be suspended for a period of 28 days, the suspension to start at 00:01 hours on 4th February 2011 and end at 00:01 hours on 4th March 2011;

b) the Licence holder be required to undertake by 4th March 2011 appropriate training (to the satisfaction of the Licensing Officer) in passenger safety, namely requiring passengers to wear seatbelts and ensuring passengers in wheelchairs etc are correctly secured in the vehicle before the fare is taken; and

c) in the event that the requirement in paragraph b)is not complied with the Drivers Licence remain suspended until such time that it is completed.
