1 <u>Reasons for the Scrutiny</u>

- 1.1 The decision to undertake the scrutiny of Gosport bus services was taken at a meeting of the Overview and Scrutiny Committee held on 24 June 2014 and followed the receipt of representations to the committee by the Gosport Older Persons' Forum and a Vice-Principal of St Vincent College regarding the declining standards of some bus services. These representations were received at an extraordinary meeting held on 31 March 2014.
- 1.2 Much concern has also been expressed by local residents about local provision and the frequent changes that have taken place. This is evidenced by the number of complaints received by members as well as frequent coverage in the local press. There have been at least five petitions launched in the Borough.
- 1.3 Many Members were aware that they were insufficiently informed about local services and the factors influencing provision.

2 <u>The Working Group</u>

- 2.1 This comprised Councillors Farr, Scard, Beavis and Forder.
- 2.2 Lisa Young (Democratic Services Officer) and David Duckett (Head of Transport and Traffic) serviced and advised the Working Group.

3 <u>Progress of the Scrutiny</u>

3.1 There were five meetings of the Working Group as well as many informal contacts by email, telephone and face-to-face. Notes of these meetings are attached as appendices.

- 3.2 The five formal meetings were as follows:
- 3.2.1. 8 July 2014.

The parameters of the scrutiny were agreed.

3.2.2 28 July 2014.

A presentation was received from Peter Shelley, Head of Passenger Transport, Hampshire County Council, who was also questioned on his evidence. Following this meeting all Gosport Borough councillors were invited to forward their constituents feedback or concerns to the Working Group and a number did.

3.2.3 2 September 2014

In the light of the evidence received the Working Group considered a draft of the conclusions to be drawn and also considered some research undertaken by national authorities.

3.2.4 14 October 2014

Peter Shelley, Head of Passenger Transport, Hampshire County Council and Councillor Peter Davies (Fareham Borough Council) also attended this meeting and gave their reactions to some provisional findings. Following this meeting Councillor Forder contacted Councillor Sean Woodward, Executive Member for Economy, Transport and Environment to acquaint him with the Working Group's provisional findings and received a reply. See Appendix 6.

- 3.2.5 25 November 2014. The Working Group's initial conclusions were presented to Marc Reddy, Managing Director of First Bus and he answered these in detail. See Appendix 5.
- 3.2.6 A member of the Working Group compiled a list of transport alternatives available from the voluntary sector. See Appendix 1.

4 <u>Main findings</u>

- 4.1 The past couple of years have seen changes to bus services in the Borough. In particular, the introduction of the busway has been highly successful in increasing levels of service and patronage on the new Eclipse routes which have won national and local awards. There has also been substantial investment in new buses (including micro-hybrids) and other technical improvements to benefit customers, such as Wifi, next stop audio and visual announcements and smart card and mobile ticketing. See Appendix 5.
- 4.2 All commercial services in Gosport are operated by First Bus, two of which are subsidised by Hampshire County Council. During the course of the

scrutiny members of the Working Group became aware of a change of philosophy by the operator. Frequent "Turn Up and Go" services on a simpler network are now favoured and are believed to be more viable and successful in growing patronage than less frequent services with circuitous routes. However the resulting far reaching changes to routes and frequencies has had a cost for potential customers who live some distance from the main routes. Unfortunately, these individuals are often older, more vulnerable and dependent on bus services. As such they are at an increased risk of isolation.

- 4.3 Members of the Working Group became aware of unfortunate and unintended outcomes arising from the concessionary travel scheme currently providing free travel for older people. The sums received by the bus companies can be too small to make services viable, particularly in areas with a low demand from paying passengers, such as Anglesey and Lee-on-the-Solent.
- 4.4 Two services, the 11 and 21, are currently subsidised by Hampshire County Council. Regrettably the subsidy for these two routes will be cut from £96,785 to £87,112 effective from 5th January 2015 meaning that the No. 11 Saturday service will be removed and the No. 21 route will be altered so that Lee-on the-Solent is no longer served. The only service remaining which serves Lee-on-the Solent will be the X5. We regard these reductions as regrettable particularly as Gosport receives relatively little in the way of subsidies compared to other parts of the County.

- 4.5 In March 2013 the 85 and 88 services were replaced with the 9 and 10 on revised routes. This has brought improvements for some residents, although Tukes Avenue residents no longer have a service to the shops in Nobes Avenue. First Bus advise that these difficulties can be overcome by residents changing between the No. 9 and 10 services. Alternatively the 9 provides a 15 minute service to the Rowner Health Centre and the shops in the Carisbrooke Precinct and Rowner Lane. It may well be that local residents are not aware of these alternatives. First Bus indicated that they would be willing to clarify this for residents.
- 4.6 The service through Anglesey along Clayhall Road has greatly deteriorated as a result of changes implemented in January 2014 and subsequently. The old No.9 service, partially subsidised by Hampshire County Council formerly offered a half-hourly service well into the evening and at weekends. The new No. 11 provides just six buses a day with no service at weekends or on public holidays.
- 4.7 Residents of Peel Common have suffered a reduced services and lost links to Newgate Lane since the removal of the 87 and 87A services along Rowner Road in March 2013.

- 4.8 Lee-on-the-Solent residents have expressed widespread concern about the lack of services in Lee.
- 4.8.1 A Lee resident has raised a number of issues about the revised X5 service (Gosport–Fareham-Locks Heath-Southampton) and collated a number of complaints and collected a petition. Although the service now operates half-hourly (rather than hourly) the total journey time from Gosport to Southampton is now nearly 2 hours and from Lee about 1 hour 40 minutes. First Bus advise that the complete journey to Southampton is only made by 3% of passengers. Further, this will be the only remaining service from Lee to Fareham College, the railway station and the shopping centre following the removal of the 21 service from January 2015.
- 4.8.2 There have been a number of complaints about X5 unreliability and local shop and business owners have complained about the impact of this on their businesses. It seems that this is in large part due to the length of this route making it more susceptible to delays which make it difficult to adhere to the timetable
- 4.8.3 There is no bus service along Marine Parade East where a significant number of elderly residents live.
- 4.9 Many frequent radical changes have created confusion and may have reduced custom. It is understood that a radical restructuring of services was required as in the wake of the introduction of the Eclipse services and reduction in subsidised services. Having said that, it is hoped that we may now be entering a period of greater stability once the issues identified above have been assessed.
- 4.10 Some services terminate too early to be of use to commuters. Examples are:
 - No. 10 last service from Gosport ferry at 1635 and Fareham Bus Station at 1545.
 - No. 11 leaving Fareham at 1735 and Gosport Ferry for Alverstoke at 1806
- 4.11 The development of through ticketing would be most welcome. We are therefore encouraged to learn of the introduction of a smart card (SolentGo) and other on-going developments which include the Gosport Ferry.

4.12 In some cases new bus shelters do not serve bus routes and stand as public reminders of what is perceived as a decline in services. However we also understand the reluctance to remove shelters until revised routes are firmly imbedded given past experience of changes being instigated and then reversed.

- 4.13 We are encouraged to learn of First Bus's plans to establish new customer panels for South Hampshire, one of which will be for Fareham and Gosport.
- 4.14 The need for a direct bus service to Queen Alexandra Hospital has often been mentioned but has proved impractical. Currently it is possible to interchange at Gosport bus station (and use the ferry to cross to the Hard) or Fareham bus station.

4.15 It is apparent that commercial operators are unlikely to be able to offer a level of service which many members of the public expect and need. Consequently we are of the opinion that there is a need to engage with the voluntary sector and others to find a way forward. See Appendix 1.

5.0 **Recommendations**

- 5.1 We regard recent Hampshire County Council reductions in subsidy to local services as regrettable and would encourage those with authority in this matter to resist further reductions.
- 5.2 To address the issues identified at 4.2 and 4.15 it is recommended that the Council host a meeting with the voluntary sector designed to develop a better understanding of how they can work alongside commercial and subsidised services and explore ways of providing enhanced services to those at risk of isolation.
- 5.3 That the Working Group endeavour to report back their findings and recommendations to members of the public who have participated in the Scrutiny.
- 5.4 That Gosport Borough Council. Hampshire County Council and First Bus continue to explore ways of improving communication and sharing information.
- 5.5 That the Overview and Scrutiny Committee ask First Bus to clarify the issues raised at 4.5.

Alternative Providers (Mainly Voluntary Sector)

There are a number of alternative transport options for Borough residents. Services include.

- Driving Force volunteer drivers to transport people from Gosport to Queen Alexandra Hospital. The criteria are that residents must be OAP's and live in Gosport. The cost is 49p per mile, which equates to £12 return to the QA Hospital. Contact details are 07722743217
- Lee-on-the-Solent Voluntary Care Group provides transport for the Lee-onthe-Solent residents who are elderly, housebound and incapacitated to hospital, medical appointments and miscellaneous requirements. Also provide transport for weekly lunch clubs if necessary. Transport is in volunteers' cars and can normally accommodate Zimmer frames and fold up wheelchairs. A contribution is charged for the journeys based on return mileage. Contact 02392 554607
- Gosport Voluntary Action Dial-a-ride and Lee ICANGO provided by the voluntary sector. Dial-a-ride available Monday – Friday 9am – 4pm, must be pre booked. For residents who cannot use buses, but not for medical appointments. Fares similar to buses. Also organise day trips. Dial-a-ride 01329 22315,1 ICANGO – 07787 292 666
- Travel costs for cancer patients may be refunded if patient is in receipt of selected benefits for more information contact Macmillan 08088 080000
- CEMAST The CEMAST campus has a new bus stop right outside offering good transport links to Gosport and Fareham. Two new dedicated bus services will run twice in the morning and twice in the late afternoon. CEMAST Route 1 will run from Fareham bus station and railway station calling at stops along the Eclipse BRT before arriving at CEMAST. Route 2 will offer a new service from the Gosport Ferry to the CEMAST site. During the day a shuttle service will operate between CEMAST and the BRT interchange at Fort Brockhurst. Journey times for both routes will be less than 25 minutes.

2 Discussion at the meeting

- 2.1 Peter Shelley presented to the Group on Bus Services within the Borough. He advised on the history of the Bus Services in the Borough and changes to the services over recent years. He suggested that current thinking was that fewer, more frequent services made better financial sense.
- 2.2 The Group were advised of the changes that had taken place to routes since the introduction of the Eclipse buses in 2012.
- 2.3 The Group was also advised of a summary of changes in general, including the introduction of newer buses and cheaper weekly tickets specifically targeted at Gosport and Fareham usage.
- 2.4 The Group was also advised of some financial figures and formulae surrounding concessionary fares funded by Hampshire County Council, and routes that were also subsidised.

3 <u>Conclusion</u>

- 3.1 The Group agreed that Peter Shelley's presentation had been clear and informative and helped to clear up a number of outstanding questions.
- 3.2 There was continuing concern about the provision of services in some parts on Lee-on-the-Solent, Bridgemary and the Clayhall area.
- 3.3 The Group understood the opening of the BRT and induction of the Eclipse buses was bound to have an impact on other services on the peninsular but thought that the public relations aspect of some other changes could have been better handled.
- 3.4 The Group felt the new timetable needed the opportunity to settle, but felt that they would like to offer First Bus the opportunity to speak to them in late September early October to explore some issues outlined above.
- 3.5 The Group also felt that they would like a blanket email sent to all Councillors requesting observations on bus services.

1 Background

- 1.1 This was the third meeting of the Bus Services Working Group.
- 1.2 The purpose of the meeting was discuss the issues identified as of most concern to Members and Residents and establish how the group should move forward
- 1.3 David Duckett was invited to continue to provide support to the Group.
- 1.4 Councillor Forder provided the Group with a summary of issues identified, correspondence from ward Councillors regarding bus services, correspondence from members of the public regarding bus services and details of 'Greasing the wheels' research undertaken by the institute for Public Policy Research in 2014.

<u>2</u> <u>Discussion at the meeting</u>

- 2.1 The Members discussed, in detail, the individual points identified. Members also potential and realistic options for improvement. These included the X5 service through Lee-on-the-Solent not continuing through to Southampton, and becoming a service that ran from Fareham to Gosport via Lee-on-the –Solent. This would help address the non reliability of the current service, often heavily affected by traffic.
- 2.2 Members discussed the ownership and options for bus stops that were no longer in use.

- 2.3 The group discussed the reduction in evening services and the subsequent affect the reduction had on the availability of services for commuters.
- 2.4 The Group discussed the issues with Bus Services to Queen Alexandra Hospital. The Group acknowledged that a direct bus service to the hospital from Gosport was unrealistic and that not all areas of the Town could be covered.
- 2.5 The Group acknowledged that currently the quickest way to access QA by public transport was by ferry to Portsmouth and then catching the bus to the hospital, but accessing the ferry was often difficult for elderly people.
- 2.6 The Group recognised that there were a number of other services available that offered transport for both medical appointments and other travel needs. These included ICANGO in Lee on the Solent and a free bus service to and from Asda in Fareham.
- 2.7 The group also acknowledged that any change in service would most likely inconvenience other service users and that there was not a resolution to suit everyone's requirements.

3 <u>Conclusion</u>

3.1 Councillor Forder agreed to use the information discussed at the meeting to revise the list of main issues.

It was requested that contact be made with Peter Shelley to invite himto the next meeting of the group. The group would discuss the updated list before his arrival.

Councillor Scard agreed to seek clarification with Councillors Mr and Mrs Wright regarding the service requirements in Bridgemary.

1 Background

- 1.1 This was the fourth meeting of the Bus Services Working Group.
- 1.2 Councillor Peter Davis had been invited to the meeting to discuss

David Duckett was invited to continue to provide support to the Group.

1.3 Councillor Forder provided the Group with an updated summary of issues identified, the Group were also provided with a copy of an article printed in the Portsmouth News in relation to surveys undertaken at Morrisons and Lidl regarding a direct bus service to QA hospital.

<u>2</u> <u>Discussion at the meeting</u>

- 2.1 The Group discussed the newspaper article. It was acknowledged that part of the success of the BRT E1 and E2 services was that they did not have to negotiate the 'Tesco' roundabout to get to Fareham Bus Station. In addition, the number 3 bus leaves Fareham bus station for Queen Alexandra Hospital every 10 minutes between 9-5.
- 2.2 A direct service from Gosport by amending the E1 and E2 to continue through to QA hospital would damage the reliability of the Eclipse Service. It was noted that both the Eclipse Bus and number 3 were very regular services and that a direct service would not improve

travel times as buses would need to negotiate the Delme Arms round about twice. It was also noted that residents in the south of the peninsular would more likely travel across the ferry and catch X9 or the 8.

- 2.3 Members discussed the provisional findings they had made. It was acknowledged that the bus routes had been amended to reflect demand and viability and that this had led to a loss/reduction of service on previously amended routes.
- 2.4 Members acknowledged there was confusion for members of the public as bus routes and timings were frequently changing and recognised that stability would be welcomed.
- 2.5 It was recognised that a number of late services had been reduced with a detrimental impact on availability for commuters.
- 2.6 Members were also advised that the implementation of a smart card system was imminent. It was hoped that this would eventually be able to be used with South West Trains and Ferries to the Isle of Wight.
- 2.7 Members recognised that the County Council decision day regarding bus services, following consultation, was due shortly.
- 2.8 Members recognised that it was now common place for bus services to shift from a web of routes to a more central route with more frequent services. Members discussed whether there was potential for a hub station to be developed in Gosport, to allow the provision for a more outreaching services in the Borough.
- 2.9 Concern was expressed at the services provided to Clayhall and Alverstoke, Lee- on – the – Solent, in particular Marine Parade East, the High Street and CEMAST and for the residents of Tukes Avenue.

3 <u>Conclusion</u>

- 3.1 Councillor Forder agreed to use the information discussed at the meeting to revise the list of main issues.
- 3.2 Councillor Forder agreed to contact Councillor Sean Woodward to advise him of the working groups thinking.
- 3.3 LY and BF to contact Marc Reddy to invite him to attend the next meeting of the Working Group.

1 Background

- 1.1 This was the fifth meeting of the Bus Services Working Group.
- 1.2 Marc Reddy, the Managing Director of First Bus in Berkshire, Dorset and Hampshire was invited to address the group.
- 1.3 David Duckett was invited to continue to provide support to the Group.
- 1.4 Members of the Group acknowledged that since the last meeting of the Group, Hampshire County Council had delivered their decision day in relation to Transportation and that this had an impact on the services provided to Lee on the Solent and Clayhall areas.

2 Discussion at the meeting

- 2.1 Marc Reddy gave the Group some background into the history of bus services in Gosport following the deregulation of buses in 1985.
- 2.2 The Group were advised that First Bus had operated from the area since 1997

The Group was advised that the most significant change to the network had occurred in 2012 with the introduction of the Bus Rapid Transport busway.

The Eclipse had proved to be very successful and overall, it had shown that people were prepared to walk slightly further to catch a more regular bus service. As a result of this, a redesign of the network was implemented in November 2012 with a simpler and easier to understand timetable.

Mr Reddy advised that there had been big growth on the Eclipse 2.3 Services. 3.4 millions Passengers had travelled on the route and growth in passenger numbers had been 64% in the first year and 24% in the second year. The Group was also advised that 14% of the users of the Eclipse did so instead of travelling by car. It was acknowledged that this would not reduce traffic on the A32 by 14% but that the service had led to a reduction in congestion on the road and had shown that people were prepared to use the Eclipse as an alternative to taking their car.

- 2.4 The Group was advised that the BRT had won three national awards and a local award and was recognised nationally as a success and value for money.
- 2.5 Mr. Reddy advised that a number of new ticketing methods were being introduced; these included mobile ticketing to speed boarding and allow purchases to be made before travel. The SolentGo Card had been introduced to allow travel across Hampshire.
- 2.6 The Group was advised that there had been a change in bus operator grants, the relief received on fuel duty. This had decreased from 43.21p per mile to approximately 34p per mile.
- 2.7 The Group was advised that despite these cuts, in the Solent Business Unit, comprising Portsmouth, Waterlooville, Gosport and Fareham 89 new buses had been purchased, at a cost of £13,700,000 the average age of the fleet in the area was 4 years, below the government recommendation of 8 years. In addition, micro hybrid buses had also been introduced.
- 2.8 Free Wi-Fi was being added to buses to allow people to utilise the time spent travelling and 64 buses were undergoing refurbishment and it was hoped the next step in improvements would be the introduction of next stop audio announcements and screens. It was hoped that the improvements would make buses a more attractive option for passengers
- 2.9 Mr. Reddy also advised that the Solent Business Unit comprised 160 buses and 428 staff, a large proportion of which came from Gosport.

- 2.10 Mr. Reddy advised the group, that in relation to the concerns identified it was possible to catch the bus from Nobes Avenue to Tukes Avenue, but a change of buses would be needed from the 9 service and the 10 service. It was acknowledged that customers did not like to change buses, but also that the demand for the route was most frequently from those entitled to concessionary fares and there would be no financial disadvantage in changing buses. Mr. Reddy advised that if required a leaflet could be produced detailing how to get to from Nobes Avenue to Tukes Avenue by bus.
- 2.11 In relation to the number 11 service in Anglesey, it was advised that the service had initially been funded out of the developer's contributions from the Priddy's Hard Development. When this funding expired, Hampshire County Council had continued to wholly subsidise the service and the funding for it had subsequently been reduced.
- 2.12 Although not exclusively the case, it was often shown that the bus routes that were most successful were those situated in lower socio economic areas.
- 2.13 The Group was advised that it could be possible to reintroduce the Saturday service if the funding could be found, but that 56 days notice was required to amend a timetable, unless approval was given by the local authority and the traffic commissioner. The Group was advised that the predecessors to the Number 11 service, the 29/30 were always tendered and subsidised, even when Haslar was open.
- 2.14 In relation to the services for Lee-on-the-Solent, it was advised that amendments had been made as only 3% of those travelling on the previous 72 route travelled end to end, to make the service more attractive, a stop at Fareham Bus Station had been included.
- 2.15 It was recognised that a service to Marine Parade East had been withdrawn and that Councillors had expressed concern that elderly residents could not walk the 800metres stated. The Group was advised that a decision had been made to service Cherque Farm, as the demand for service there was greater.
- 2.16 It was reiterated to the Group that routes on which the bulk of passengers were concessionary fare holders were not profitable due to the lack of reimbursement received for concessionary fares travelled. The Barnet Formula had determined the rules with the introduction of concessionary fares and could not be amended.
- 2.17 It was acknowledged that should funding become available for the reintroduction and amendment of the 21 route to include Lee-on- the –

Solent, it would not be straightforward.

- 2.18 The Group was advised that in preparation for the decision day report Hampshire County inspectors would have been travelling on journeys to access the viability of them. Members reiterated that residents in Lee on the Solent had expressed feelings of isolation at the service provided.
- 2.19 Mr. Reddy addressed the Group in relation to the recent call for a direct service to QA Hospital. It was acknowledged that the route would be unreliable, would take longer to travel to the hospital and that more regular and reliable services were already in place. It was recognised that those that used buses to hospitals were not regular travelers on the route.
- 2.20 Mr. Reddy agreed that it was important for some continuity in the network now and it was hoped that this would be accompanied by growth, in relation to the number 10 route; it was advised that its continuation was borderline as it was not a well used route.
- 2.21 The Group was advised that there were already a number of travel options that encompassed the use of Gosport Ferry.
- 2.22 In conclusion, Mr. Reddy reiterated the success of the BRT and advised that he hoped that a form of bus station would remain in its current location should the waterfront area be redeveloped.

3 <u>Conclusion</u>

3.1 The Group welcomed Mr. Reddy's input to the Scrutiny.

It was agreed that a report be presented to the next meeting of the Overview and Scrutiny Committee.

Please find attached a "provisional findings" document which has involved some substantial research and consultation. Among those we have consulted with have been Peter Shelley and Cllr Peter Davies. We are planning on meeting with First Bus soon in an attempt to take some of our findings forward.

We have learned that the date of your decision day when you announce plans for bus service subsidies in Hampshire is fast approaching and we therefore concluded that it would be timely if I made you aware of our findings. Of particular relevance, of course, are services 11 and 21 which currently benefit from a County Council subsidy.

We would be interested in any comments you have to make.

Dear Bob

Thank you for your email and the attached provisional findings of your Scrutiny Committee. I am glad to learn that Peter Shelley was able to assist you.

As you know, I have taken a close interest in bus services in Fareham and Gosport, particularly the changes to services following the successful introduction of the Eclipse Bus Rapid Transit and met with Marc Reddy, Managing Director at First Hampshire, Dorset and Berkshire earlier in the year.

Gosport is fortunate that it has an extensive commercial bus network with only the two services that you mention, the 11 and the 21, requiring public funds. At a time

when public funds remain under considerable pressure that is good news. I note that you are planning to meet First and as the majority of services are commercial, with routes and timetables set by the bus company, that is the appropriate contact as the County Council does not control or fund those services. First have shown themselves amenable to suggestions, for example the recent route change to the 9/9A in Rowner, and have recently introduced a fleet of new buses to these routes, but as I understand it, the change to the 9/9A around Tukes Avenue dates from 2012, so the company may feel less comfortable with the change.

Both the 11 and 21 were introduced in January this year to replace routes which First considered uneconomic. Certainly, our experience with the 11 along Clayhall Road shows low use as does the survey data we have when there was a half hourly bus service. The buses were quite full, but the number of passengers actually boarding or alighting on that section of route was low which was why the bus company rerouted the service to reach the most popular stop in the town centre.

With regard to the 21, I approved this on a trial basis from January. The route replaced commuter journeys from Hill Head on the 5A and shopper journeys on the former 6 and 21. The frequency is limited by what one vehicle is able to do in a day. In fact the 21 offers six journeys to Cherque Farm and Lee-on-the-Solent, three each way as it runs as a circular but I am aware that it is partly overlapped by the X5 route and the regular shopper service sponsored by Asda.

With regard to the level of bus services in Lee-on-the-Solent, in addition to the services mentioned above, the commercial X5 provides a seven day a week service to Fareham, Gosport and Southampton. One local resident has presented a series of petitions to me regarding the change from the hourly 4 to the half hourly X5, but apart from one school journey, this is a commercial service and decisions regarding it are a matter for the bus company. Those passengers on Marine Parade East who no longer have a bus service are within the 800m accessibility limit set by the Department for Transport and for those for whom this is too long a walk, the Dial-a-Ride service, which the Borough Council and County Council fund, provides an alternative. CEMAST students have their own dedicated bus service as post 16 colleges now receiving direct funding for transport.

Turning to your more general comments, I share your hope that we may now be entering a period of reduced changes to bus services.

With regard to last bus times, the 10 is a commercial service, though many points served are close to other routes which run later. I regard 1735 from Fareham and 1806 from Gosport as reasonable last journey times for those working locally. As noted above the 21 was only intended to provide shopper journeys to Lee-on the-Solent.

I believe that Peter Shelley gave you further details of the SolentGo Smartcard which launched in August and will cover bus and ferry operators. Funding for this followed a successful bid to Government.

Bus shelters are a Borough Council responsibility and it can be frustrating when bus routes change though it is often good advice to keep shelters and bus stops in situ for a time to cater for future changes.

I believe that your committee discussed the request for a direct bus from Gosport to the Queen Alexandra Hospital. The direct minibus service underwritten by the Hospital was not well used and the connecting bus services E1/E2 and 3 are now at increased frequency making the journey easier than ever so I see little demand for an additional service and certainly little prospect of further funding for it.

Thank you again for your comments. I have received a wide range of representations which I will take into account at my Decision Day on 27 October.

REVIEW OF POLLING DISTRICTS AND POLLING PLACES

Thank you for your letter dated 22 September 2014 regarding the above enclosing the Council's draft proposals.

I note that all the proposals set out in my letter dated 2 September 2014 have been included.


Since my previous letter we have continued to review the properties included within each polling districts and there are small number of anomalies which it would be useful to address in this review.

Polling District GA1 includes the property 1 Stokes Bay Road, which is the only property in Stokes Bay Road situated towards the eastern end of Stokes Bay Road geographically and is located in, and surrounded by, properties in Polling District GA3. I would therefore propose that this property should be reallocated to Polling District GA3. The residents of 1, Stokes Bay Road currently travel to Gomer Infant School to vote, should the property be reallocated to GA3, the residents will travel to Alverstoke Infant School, which is closer and would therefore significantly reduce the distance they need to travel to vote.

There are also a small number of properties that have/will be added to the register as new properties are brought into use. I will provide a full list of these new properties shortly before the final report is finalised.
