A MEETING OF THE GRANTS SUB-BOARD

WAS HELD ON 22 NOVEMBER 2006

The Mayor (Councillor Mrs Cully)(ex-officio), Chairman of the Policy and Organisation Board (Councillor Hook) (P), Councillors Mrs Champion, Chegwyn (P), Dickson, Mrs Salter, Taylor (P) and Wright (P)

It was reported that, in accordance with Standing Orders, Councillors Burgess, Hook and Smith had been nominated to attend this meeting in place of Councillors Mrs Champion, Dickson and Mrs Salter respectively.

In the absence of the Chairman and Vice Chairman, Councillor Taylor was elected Chairman for the duration of this meeting.

12. APOLOGIES

Apologies for inability to attend the meeting were submitted on behalf of the Mayor and Councillors Mrs Champion, Dickson and Mrs Salter.

13. DECLARATIONS OF INTEREST

Councillor Wright declared a personal and prejudicial interest in Agenda Item 7 (4) St Mary the Virgin Church.

14. MINUTES

RESOLVED: That the Minutes of the meeting of the Sub-Board held on 14 September 2006 be approved and signed by the Chairman of the meeting as a true and correct record.

PART II

15. REPORT OF THE FINANCIAL SERVICES MANAGER AND LEISURE AND CULTURAL SERVICES MANAGER: REVENUE GRANT AID APPLICATIONS

Consideration was given to a joint report of the Financial Services Manager and the Leisure and Cultural Services Manager (a copy of which is affixed in the Minute Book as Appendix 'A') concerning a number of applications for Revenue Grant Aid.

(i) <u>Gosport Netball Club</u>

Emily Evans, representing the Club, advised Members that a grant was being requested to assist with the purchase of kit for players between the ages of 9 – 16 years of age. The players each paid a membership subscription which went towards the cost of court fees, umpires and travel expenses, as well as the purchase of kit. The kit remained in the ownership of the Club and was passed down from player to player. Two teams had managed to attract sponsorship and other teams were seeking sponsorship.

Members were keen to offer support for a club that provided sporting activities for young people in the Borough and offered advice on further avenues of grant funding that could be pursued. Members agreed that a grant of £630 be paid for the purchase of kit for one team.

(ii) <u>Lee-on-the-Solent Tennis Squash & Fitness Club (Junior Squash Player)</u>

The Head of Leisure/Recreation & Development, representing the Leisure and Cultural Services Manager at this meeting, declared a personal and prejudicial interest in this item, left the room and took no part in the discussion thereon.

Members considered it important to encourage talented players and assist in enabling them to reach their potential and gain national ranking. It was proposed and agreed that a grant of £500 be given to the Club in support of a Junior Squash player.

(iii) Lee Singers

Consideration was given to an application for a grant of £500 towards the cost of providing two public concerts. Members were advised that the cost of hiring soloists and orchestras could not be covered by ticket sales alone unless ticket prices were raised to a level that would be beyond the range of local audiences. Members were also informed that a grant of £200 had recently been awarded by Hampshire County Council.

Although pointing out that grants were not given for the payment of wages, it was proposed and agreed to award a grant of £200 toward the cost of two public concerts.

(iv) The Bivol Trust

Jackie Jordan, representing the Trust, outlined the work carried out by the Trust in support of both children and adults with special needs. A grant of £3,000 was sought towards the cost of equipment for activities including art, craft and IT.

Funds were also needed towards the provision of outings as many of the members were unable to provide the full cost themselves.

After carefully considering the needs of the Trust and the fact that 75% of the members catered for were from Gosport, it was proposed and agreed that a grant of £1,000 be made towards the provision of equipment.

(v) <u>The Quake Games After School Club</u>

Shane Buckland outlined his reasons for forming this After School Club based at Brune Park School and explained that, following a test children's birthday party where he provided games for entertainment, he had decided some games and equipment were not suitable and had adjusted his list of requirements accordingly. Therefore, the grant now being requested was £1,280 and not £1,400 as stated in the report.

Members expressed their support for the creation of this Club that would provide after school activities for children who otherwise might become involved in anti social behaviour. In answer to a Member's question, it was confirmed that the Club equipment would be stored at Mr Buckland's home and therefore covered by his home insurance.

After considering the revised list of outstanding equipment required, it was proposed and agreed to a grant of £580 for the purchase of Wii games and equipment.

(vi) <u>Solent Kestrels Basketball – (Individual Member)</u>

Beverley Guyman, representing Solent Kestrels Basketball, explained that they had a very talented player in their Under 14 Team who was expected to make the County Squad and, potentially, could play for the England Team. The Club held fundraising events and the players each paid a subscription to the Club but further funds were needed to pay for travel to training sessions in Southampton, the cost of area performance camps and County training sessions.

Members recognised the importance of supporting talented youngsters from the Borough and it was proposed and agreed to make a grant of £500 towards the training costs for this young player.

(vii) <u>Hampshire County Youth Band Association</u>

Jill Larner, representing the Hampshire County Youth Band Association, explained that a grant was being requested towards the cost of new musical instruments that would remain the property of the Band but would be loaned to children whose parents were unable to afford to purchase them. For example a new Euphonium was required at a cost of £3,000 and a new Vibraphone costing

£1,900. The reserves currently held in the Association's account were required to cover the expenses involved in staging a number of events in the coming year, including renting venues. Plans had been made for the Band to visit Poland in the summer and a residential training weekend would also be held. Parents paid part of the cost of their children attending visits and training sessions.

Members commended the Youth Band on their high standards and the evident pride in their achievements seen by those who had attended their concerts. The importance of forging international relationships through music was also recognised. It was proposed and agreed to award a grant of £500 towards the purchase of new musical instruments.

(viii) Volunteer Reading Help

Members were concerned that no information was provided as to how many children resident in Gosport were assisted by this scheme.

It was proposed and agreed that no grant be made at this time.

(ix) <u>Vitalise</u>

Members noted that the national balance in the accounts of this organisation was £2,088,000. No representative was in attendance to answer questions as to how the requested grant would benefit disabled people and their carers from Gosport.

It was proposed and agreed that no grant be made at this time but that it be suggested to Vitalise that should they wish to make an application in the future, a representative attend to answer questions.

RESOLVED: That:

- (i) a grant of £630 be paid to Gosport Borough Netball Club;
- (ii) a grant of £500 be paid to Lee-on-the-Solent Tennis Squash & Fitness Club (Junior Squash Player);
- (iii) a grant of £200 be paid to Lee Singers;
- (iv) a grant of £1,000 be paid to the Bivol Trust;
- (v) a grant of £580 be paid to the Quake Games After School Club;
- (vi) a grant of £500 be paid to Solent Kestrels Basketball (Individual Member);
- (vii) a grant of £500 be paid to the Hampshire County Youth Band Association;

- (viii) no grant be made to Volunteer Reading Help; and
- (ix) no grant be made to Vitalise but it be suggested that a representative attend to answer questions should they make an application in the future.

16. REPORT OF THE FINANCIAL SERVICES MANAGER: CAPITAL GRANT AID APPLICATIONS

Consideration was given to a report of the Financial Services Manager (a copy of which is affixed in the Minute Book as Appendix 'B') concerning a number of applications for Capital Grant Aid.

(i) <u>Bridgemary Centre</u>

Rosellen Lambert, on behalf of the Bridgemary Centre, explained to Members that the Centre was based at Nobes Hall which was owned by Gosport Borough Council but run by the Centre on the Council's behalf. RL considered that it was a nice building but the floor that had been installed was non-slip and therefore not suitable for dance or fitness activities. In order to maximise the potential for bookings at Nobes Hall, an alternative floor was needed. A multi-purpose semi permanent flooring had been identified that could be laid on top of the existing floor but could be removed at a later date without damage to the original floor if necessary.

Whilst acknowledging that it was usual to only make grants of up to 50% of the amount required by an applicant for any one project, Members agreed that, as Nobes Hall was owned by the Council, an exception could be made in this case. Therefore, it was proposed and agreed that a grant of £3,000 should be made.

(ii) Hardway, Elson & Districts Community Association

Debbie Utley, representing Hardway, Elson & Districts Community Association (HEDCA), explained how the Hedca Centre at Coombe Road, Elson, was formed in 1957. The floor of the hall was made from wood mosaic strips that had become thin and worn and were now lifting, causing trip hazards. Repeated sanding over the years had made the original pieces very thin and attempts to replace individual tiles had been unsuccessful. The hall was in use for approximately 75% of the year for a wide variety of functions and activities. The Association requested a grant towards the cost of replacing the floor for which an estimate of £18,899 had been obtained.

In answer to Members questions it was confirmed that the hall was owned by Hampshire County Council and an application for a grant had also been made to Hampshire County Council. Members expressed the view that this was an extremely well used hall, providing important facilities to the community. It was proposed and agreed that a grant of £7,000 be awarded.

(iii) <u>St Mary the Virgin Church</u>

Councillor Wright declared a personal and prejudicial interest in this item, left the room and took no part in the discussion or voting thereon.

The Reverend John Draper, on behalf of St Mary the Virgin Church, addressed the Sub Board. He confirmed that accounts to the year end 2005 had been presented to the Council. He explained that the Churchyard at St Mary the Virgin was unique in being the only open churchyard in the Borough and it had been used for burials since Roman times. He said that maintenance of the Churchyard was expensive, especially in view of the need to comply with Health and Safety Regulations.

After giving consideration to the type of work that was required in this historic Churchyard, it was proposed and agreed to award a grant of £9,466.

RESOLVED: That:

- (i) a grant of £3,000 be paid to the Bridgemary Centre;
- (ii) a grant of £7,000 be paid to the Hardway, Elson & Districts Community Association; and
- (iii) a grant of £9,466 be paid to St Mary the Virgin Church.

1 Background

1.1 Voluntary and Community Groups are able to apply for grants from the annual revenue budget available to the Grants-Sub Board.

2 GOSPORT FOOTBALL CLUB

- 2.1 This Club was formed in 1994, it currently has 168 junior members all of whom live in the Borough.
- 2.2 This Football Club is based at St Vincent Leisure Centre and trains children aged 6 to 18 years old to participate in competitive football leagues. They train on Tuesday, Wednesday and Thursdays, with matches held on the weekends. Members each pay £1.50 per session.
- 2.3 A grant of **£600** is requested toward an overall estimated total cost of £1,310 to purchase training equipment.
- 2.4 The breakdown of equipment required includes: Footballs £500 Bibs £250 Cones £120 Training Ladders £150 Gloves £50 Goals £240 Total £1,310

- 2.5 Gosport Football Club have not applied to any other organisation for support for this project, nor have they previously applied to the Grant Sub Board for funding.

3 LET US PLAY SCHEME (LUPS)

- 3.1 This parent led charity was formed in 1986, to provide playschemes for children with profound and complex disabilities. There are currently 90 participants aged under 18 years old, of which 45 live in the Borough.
- 3.2 The aim of these playschemes is to provide the children with fun activities to enable them to achieve at their own level. Each child needs at least 1:1 support, this service also provides the families with valuable respite.
- 3.3 A grant of **£4,000** is requested towards providing equipment. The total estimated cost of this project is £43,000.

- 3.5 Playschemes are based at St Frances School in Fareham. Operating week days only in school holidays from 9 am to 4 pm each day. Parents contribute £7 per day per child.
- 3.6 LUPS have received funding, from Hampshire County Council (Social Services) of £16,000 and £7,000 from the Children's Fund.
- 3.7 They have applied to Fareham Council for £1,500, to Children In Need for £9,000 and to Lloyds TSB Foundation for £3,000 the outcome of these applications will be updated at the meeting.
- 3.8 LUPS have previously received grants from the Grant Sub Board

4 CHAMPIONS CLUBS – ROYAL SAILORS REST

- 4.1 The Champions Clubs were formed in 1999, they currently have 78 participants aged under 18 years old, of these 75 live in Gosport.
- 4.2 The Champions Clubs are Christian based and operate from the Royal Sailors Rest, Grange Lane, Rowner. They provide a range of children's services to all local families. These include an after school club on Monday and Wednesdays, a youth club on Fridays, a beech = tree, beach = bucket + spade family day event in August, a residential holiday in April, school holiday activities and a toddler session every Tuesday.
- 4.3 A grant of **£1,350** is requested towards the total estimated cost of £2,700 to provide equipment and to subsidise the cost of the residential holiday.

- 4.5 The Champions Clubs received £17,000 core funding in 2003 towards wages and on cost from the Children's Fund for three years. They also received £200 from the Rotary Club in Aug 2006.

- 4.7 Accounting information for the period ending March 2006 shows: Income £2,713 Expenditure £10,721 Balance - Deficit £8,007 Finances are kept within the Royal Sailors Rest Accounts who cover the annual operating deficit.

5 GOSPORT & FAREHAM EASTER FOLK FESTIVAL

- 5.1 This festival is the biggest indoor folk festival in England, it has been held each Easter since 1992. It was originally based at Thorngate Halls until 1998 and has been based at Fernham Hall, Fareham since then.
- 5.2 There are 12 committee members, 30 volunteers and an estimated 10,000 members of the public who attend the events.

- 5.3 It is estimated at of those attending the festival approximately 35% live in Gosport, 35% in Fareham and 30% from elsewhere.
- 5.4 A grant of **£500** is requested towards an estimated total cost of £1,000 to support festival events in Gosport.
- 5.5 Events in Gosport include informal concerts and session at The Clarence Tavern and dance displays in the Town Centre.
