Consideration was given to a joint report of the Financial Services Manager and the Leisure and Cultural Services Manager concerning a number of applications

for Revenue Grant Aid.

(i) <u>Gosport Football Club</u>

Note: Councillor Taylor declared a personal and prejudicial interest in this item, left the meeting room and did not take part in the discussion or voting thereon.

Mr Suraci represented Gosport Football Club and advised the Sub-Board that the Club had been formed in 1994 and currently had 168 members. It worked with St John's School and charged £1.50 per player per session. The rent for the pitch used by the Club had been raised but the Club was reluctant to pass on this additional cost to the players. Some players were subsidised as they had difficulty in paying for the sessions.

The Club held a balance in reserve for Summer tournaments for which payment in advance was required.

The Sub-Board approved the Club's request for grant aid of £600 towards the overall estimated cost of purchasing training equipment.

(ii) Let Us Play Scheme - LUPS

Mr Barron represented LUPS and advised the Sub-Board that the playscheme catered for severely disabled children in Gosport and Fareham, providing a high level of one-to-one support. LUPS was applying for grant aid to help fund the upgrading of equipment.

LUPS had applied to Fareham Borough Council, Children in Need and the Lloyds TSB Foundation. It was anticipated that information regarding grant aid from these organisations would be known by the end of April 2007.

It was proposed and seconded that grant aid in the sum of £1,900 to LUPS be approved to assist with the provision of sensory equipment.

(iii) <u>Champions Clubs – Royal Sailors Rest</u>

Note: Councillor Mrs Salter declared a personal and prejudicial interest in this item, left the meeting room and did not take part in the discussion or voting thereon.

Mrs Gueran and Mrs Smith represented the Champions Clubs and advised the Sub-Board that the organisation was a Christian charity which ran a number of clubs for young people together with a half-term holiday club where children were taken on a residential holiday for three to four days.

- 2.3 The Group aim to ensure quality of care for pensioners in hospital and care homes and to fight for a non-means tested pension based on average earnings.
- 2.4 Wessex Pensioners Convention requests a grant of **£247** towards the annual cost of printing and distributing copies of the newsletter.
- 2.5 No grants have been previously awarded by this Sub-Board to the Group.

3.0 Association of Search & Rescue Hovercraft, Gosport Branch

- 3.1 The Association, based at Elmhurst Business Park, was formed in April 2005 to assist emergency and rescue services with the saving of life or property within the county of Hampshire.
- 3.2 The Associations Members have undertaken a major refurbishment of the Gosport Rescue Hovercraft over the winter 2006 spring 2007 including changing the engine at a cost of £1,500.
- 3.3 Now that the craft is reaching operational level, crew and pilot training has begun, this includes familiarisation with; maintenance, operation and support of a five seat amphibious hovercraft, use of VHF marine radio, first aid at sea and hovercraft operation. The Association aim to increase its membership by 4/5 to man the craft.
- 3.4 New equipment will need to be purchased for the use of the crew once the craft is fully operational.

- 5.2 The Ice Hockey Club is based at the Gosport Ice Rink and coaches children every week aged under 19 years old. They train on Tuesday, Thursday, and Sunday, with league games from September to May. Members each pay £5 per session.
- 5.3 The Gosport & Solent Ice Hockey Club would like to buy kit equipment to loan to members who cannot financially afford to purchase the kit themselves. The club wish to provide financial help to those aged between 16 to 19 years old who have difficulty in paying the memberships fees as they enrol in higher education by providing training in coaching that these members can utilise. The club are also starting new womens teams for members aged under 14 years old and above as age requirements are different for women to participate.

6.0 Gosport Borough Cricket Club

- 6.1 This club was formed in 1965 and they currently have 140 members aged between 6 to 60+ years old, of which 133 live in Gosport.
- 6.2 The cricket club will be based at the Clock Tower Pavilion at Privett Park when construction has been completed. The club currently have 4 adult teams that train on a Saturday and 1 team that train on a Sunday. 7.0 Youth Music Theatre Individual Member

- 7.1 Youth Music Theatre UK was formed in 2003 and currently has 500 members. Members are aged between 6 to 59 years old.
- 7.2 Youth Music Theatre UK is a registered charity that provides annual residential and non-residential music theatre courses for young people aged between 11 21 years old. The theatres principal aim is the personal and creative development of young people which is delivered through the medium of music theatre.
- 7.3 Youth Music Theatre UK is applying on behalf of a 12 year old member from Gosport. He is a student at the Jubilee School of Dancing in Gosport where he has attended for 7 years and has passed many exams and achieved a high standard in Ballet, Tap, and Modern Dance. He also attends Dance Connection where he has excelled in 26 examinations achieving Highly Commended or Honours in Ballroom, Latin American, and Line Dancing.
- 7.4 This member successfully auditioned in January in London this year and has been offered a place at the newly commissioned Youth Music Theatre UK production called Dance! This production will be performed at the Waterfront Hall in Belfast and this member will be required to be in Belfast from 10th 26th August 2007. In preparation for this production he is required to attend a 17 day residential musical theatre training course.
- 7.5 A grant of **£387.50** is requested towards an overall estimated total cost of £775 for this individual to attend the course. This request does not include additional fees required such for transport, accommodation, and parents accompanying costs.
- 7.6 Youth Music Theatre UK has not applied to any other organisation for funding to support this individual however if the grant is awarded then the individual can apply to the Youth Music Theatre UK Hardship fund for a further £256 (one third of his total course fee).
- 7.7 Youth Music Theatre UK has not previously applied to the Grants Sub

Board.

7.8 The balance on the bank statement from 17th April 2007 is £48,089.72.

8.0 Gosport BMX Club

- 8.1 This club was formed in 2006 and it currently has 40 members aged between 6 to 59 years old, 36 of whom live in Gosport.
- 8.2 The BMX Club is a member of the British Cycling Association and is based at the BMX track in Grange Road. The club is in its early stages of development with strong community support. At present the days for training and coaching sessions are being finalised but the club aim to operate on Sunday mornings either weekly or fortnightly to give local young people a fun and safe environment to play, socialise, and develop their riding skills.
- 8.3 Gosport BMX Club aim to provide regular training programmes and technical support once a week in the winter and twice a week in the summer to encourage and increase participation. At these training sessions protective equipment will be loaned to members who cannot afford to purchase it. By doing this the club are adhering to health and safety requirements set out by the British Cycling Association.

Coaching cannot take place until volunteer members have had courses in British Cycling Level 2, First Aid, and completed CRB checks.

- 2.2 ROME aims to give residents a say in what happens in their neighbourhood and to help build community spirit. The group has a total of seven volunteer committee members providing activities and events to approximately 350 members of the local community.
- 2.3 The group have organised activities and events for all age groups for several years including;
 - Healthy eating Christmas dinners for the last four years
 - Sending two groups of young people on outward bound trips
 - Maintaining a community garden
 - Helping residents make costumes for the Gosport Carnival
 - Taking young people rock climbing
 - Organising a Halloween event with a barbeque and fancy dress
 - Easter egg hunts
 - Co-ordinating the painting of four large murals
- 2.4 The group's activities are restricted to being mainly out of doors due to the lack of a community building. Indoor activities are currently staged in Salvation Army Centre at The Crossways.

- 2.5 The group have the opportunity to create a Community Hall by converting an existing cleaners store on the estate. Portsmouth Housing Association has agreed in principle to the conversion and none of the residents have raised any objections to this taking place.
